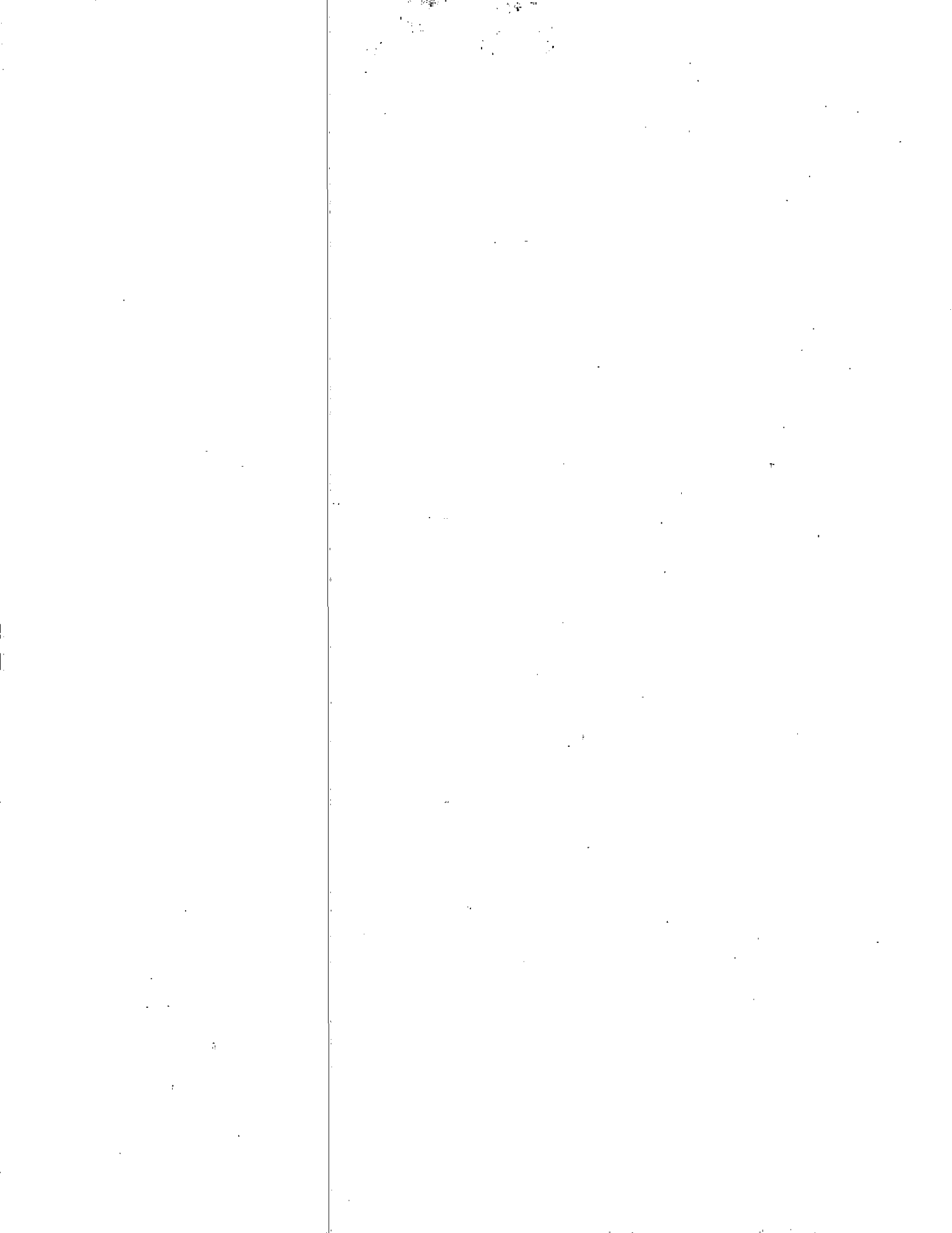
Q: Contrary to the County's Q&A's reference on page 3, we were not able to locate the subscriber list in the attachments of Amendment 005. Was it the County's intention to provide this list?

A: The County inadvertently omitted placing the updated subscriber list. It will be uploaded as a separate posting on eMaryland Marketplace and will be available on the County web site: www.stmarysmd.com/radiorfp.

Q: For clarification of 5.1.9, we request the threshold for time interval be lowered to 30 seconds or less.

A: The County will allow for the reduction from up to 3 minutes for interference monitoring per event to up to 30 seconds.

Q: For clarification of 8.1, password protection (on a configurable radio programming basis) to gain access to the radio for normal system usage is not a feature that is in any Harris P25 radio and therefore is proprietary to the other




vendor.

A: The County is removing the password access requirement.

All other terms and conditions remain unchanged.

Except as provided herein, all items and conditions of the document referenced in item 9A or 10A, as heretofore change, remains unchanged and in full force and effect.
