### **Key Planning Themes**



- Strong appreciation and desire to preserve the county's rural, agricultural landscape and views
- Protecting vulnerable coastal, wetland, and other natural areas from development
- Balanced land use that supports redevelopment and development in growth areas while protecting the county's rural heritage



### **Key Planning Themes**



- More options for walking and biking to destinations and on trails
- More and improved public transportation options within the county and to outside destinations
- Improving the county's roadway network and addressing safety and traffic issues



### **Key Planning Themes**



- The need for more affordable and attainable housing for people at all stages of their lives
- Providing a wider variety of housing options in growth areas is an important solution to help everyone, including critical employees, find a place to call home
- Action to address the need for better and expanded wastewater treatment options in certain areas of the county



#### **Engagement Satisfaction**




How likely are you to participate in future St. Mary's 2050 public engagement activities?

## **Engagement Objective #1 Engagement Satisfaction**




Were you comfortable sharing your ideas and opinions today? Choose one.

■ 0% Uncomfortable



## **Engagement Objectives**Representative Engagement (Race)





6% of county residents are Hispanic/Latinx







### **Engagement Objectives #2**

#### Representative Engagement (Primary Residence)

- ✓ Most participants skipped this question but of those who answered, 16 of 27 zip codes within St. Mary's County were represented
- ✓ 2 zip codes from outside the county (those who work but do not live in SMC)








## Engagement Objectives #2 Representative Engagement (Live/Work Map)

- This map was used for all Community Visioning Sessions; attendees added dots for where they lived and worked
- Dot locations aligned with population and employment density









# Community Engagement Window #1: Online Community Visioning Survey Results



## Online Community Visioning Activities Results: Key Priorities Survey

- Question 1: Almost all (91%) agreed or strongly agreed that land use in SMC should be balanced, with protection of rural areas and growth in growth areas
- Question 2: 78% either agreed or strongly agreed that Development Districts and Town Centers should be the focus for new development and redevelopment
- Question 3: 84% either agreed or strongly agreed that Village Centers should support small-scale businesses & tourism, and serve as local shopping centers for rural residents
- Question 4: 77% either agreed or strongly agreed that new infrastructure (water-related & roads) is needed to support development in growth areas
- Question 5: 63% either agreed or strongly agreed that 'package' sewer treatment plants should be considered for wastewater services in areas with failing septic



## Online Community Visioning Activities Results: Key Priorities Survey (cont.)


- Question 6: 77% of participants either agreed or strongly agreed that the county could use more options for walking and biking (transit and recreation)
- Question 7: 76% of participants either agreed or strongly agreed that providing smaller homes and townhouses in growth areas is an important solution to ensure that young families, professionals, and critical employees (fire, police, nurses, teachers, etc.) can find housing
- Question 8: 66% of participants either agreed or strongly agreed that providing new multifamily housing in growth areas is an important solution to ensure that young families, professionals, and critical employees (fire, police, nurses, teachers, etc.) can find housing
- Question 9: No consensus on whether providing manufactured/mobile homes in growth areas is a good solution to increase housing: 35% agreed, 41% disagreed or strongly disagreed, 22% were neutral
- **Question 10: Nearly all (93%)** participants either agreed or strongly agreed that sensitive natural resources should be protected from development impacts



## Online Community Visioning Activities Results: Key Priorities Survey

#### **Question 11: Public Spending Priorities Ranking**

- Public schools and EMS/Fire/Sheriff services, and road improvements were ranked as the top 3 spending priorities, with land preservation in 4<sup>th</sup>
- Many respondents added their own ideas under 'Other,' like public transportation or libraries










