The Dept. of Land Use and Growth Management is requesting a public hearing be scheduled to amend a Critical Area Overlay from Rural Conservation Area (RCA) to Limited Development Area (LDA). A growth allocation of 6.1 acres along Snow Hill Manor Road is necessary to approve a proposed sewerage reserve that will provide septic disposal for a vacant grandfathered LDA lot. Because the building lot has poor soils that will not perc, it was determined that the Sewer Reserve Area (SRA) must be located across Snow Hill Manor Road on a parcel with suitable soils. In August 2014 the Planning Commission held a public hearing on this subject and issued a positive recommendation to go forward.

I move that the Department of Land Use and Growth Management be authorized to schedule a Public Hearing on the proposed Growth Allocation.
