Commissioner Jarboe moved, seconded by Commissioner Morris, to authorize Commissioner President Russell to sign the Equitable Sharing Certification Report from the Department of Treasury, on behalf of the St. Mary's County Sheriff's Office. Motion carried 4-0.

3. Department of Human Services (Cynthia Brown, Interim Director; Kelsey Bush, Youth Coordinator)

Commissioner Morgan moved, seconded by Commissioner Morris, to approve and authorize Commissioner President Russell to execute a budget amendment that will increase the Department of Human Services FY2011 budget by \$6,371, using the

BOCC Emergency Reserve, for leased space/rental costs through June 30, 2011, for child protective services to remain intact. Motion carried 4-0.

4. Department of Public Works and Transportation (George Erichsen, Director)

Commissioner Morgan moved, seconded by Commissioner Jarboe, to authorize Commissioner President Russell to sign the Quick Claim Deed conveying part of the 60 ft. right-of-way on South Shangri-La Drive from the Board of County Commissioners for St. Mary's County, Maryland to the St. Mary's County Metropolitan Commission. Motion carried 4-0.

Commissioner Jarboe moved, seconded by Commissioner Morris, to approve and authorize Commissioner President Russell to sign Public Works Agreement Addenda guaranteeing construction of the roads in the: (1) Avonlea Subdivision, Section 2, Phase 1, located in the 5th Election District, with an expiration date of March 1, 2012, and Phase 2 and 3, with expiration dates of February 1, 2012; and (2) Woodland Park Subdivision, located in the 8th Election District, with an expiration date of April 1, 2012. Motion carried 4-0.

Commissioner Jarboe moved, seconded by Commissioner Morgan, to approve and authorize Commissioner President to sign the Claim Letter in the amount of \$120,600 to the American Southern Insurance Company for the Public Works Agreement issued for the Woods of Rue Purchase Subdivision, located in the 8th Election District, and based on the Department's certified correspondence dated March 8, 2011. Motion carried 4-0.

DISCUSSION AND DECISION ON THE ENTRANCE FEE PROPOSAL FOR ELMS BEACH PARK AND MYRTLE POINT PARK

Present: Phil Rollins, Director

Mr. Rollins recapped discussions from a previous BOCC meeting concerning proposed entrance fees for access to Elms Beach and Myrtle Point Park to pay for personnel to monitor the parks on holidays and weekends to alleviate issues like overcrowding, alcohol consumption and unruly behavior. Originally staff proposed \$5 per vehicle per day or \$20 per vehicle for resident access to both parks and \$10 per vehicle per day for non-County residents. Staff was asked to revisit the issue by calculating how much non-residents would have to pay if an entrance fee was not imposed on residents. After further review Recreation and Parks' staff provided 3 alternatives: (1) to implement original recommendation (\$5 per car/\$20 per season for residents and \$10 per car for non residents), (2) charge non-residents \$20 entrance fee for Elms Beach and Myrtle Point and (3) not to adopt entrance fees for either at this time.

Commissioner Jarboe moved, seconded by Commissioner Morris to approve charging non-residents a \$10 car fee and \$15 per van fee or Elms Beach Park and begin implementation on Memorial Day weekend 2011. Motion failed 2-2.

Commissioner Morgan moved, seconded by Commissioner Morris, that for both Elms Beach and Myrtle Point we charge the non residents \$10 per car per visit and \$15 per van and we concur with Mr. Rollins that residents will be \$5 per car or \$20 per yearly pass for the period beginning on Memorial Day 2011 and that we limit this to a one year deal and then staff research and report back at end of year for options, solutions. Motion carried 3-1. Commissioner Jarboe voted nay.

DISCUSSION AND DECISION ON WICOMICO SHORES GOLF COURSE PRIVATIZATION OPTIONS

Present: Phil Rollins, Director, Dept. Recreation and Parks Robert Richardson, Chair, WS Golf Course Adv. Board

The County has self-managed the golf course and restaurant for more than twenty years and until recently the facility has been financially self supporting. Over the last two years the operation has suffered a significant financial loss which is attributed to the recession. Golf play is down 15% which equates to a loss of revenue of about \$210,000 per year. The Golf Advisory Board is recommending that the facility not be privatized at this time. The Golf Advisory Board has created a marketing committee to focus on marketing and promoting the restaurant, banquet room and golf course. With increased marketing, modest fee increases and reduction in expenditures, it is anticipated that this year the facility will not operate in the red.

Commissioner Morgan moved, seconded by Commissioner Morris, to direct staff to continue with self-operation of the Wicomico Shores Golf Course facility and that you are allowed to go through this season, and if at the end of the season (November 1, 2011) you are in the red, then we are going to have to consider privatization. Motion carried 3-1. Commissioner Jarboe voted nay.

PUBLIC HEARING ON PROPOSED COMPREHENSIVE WATER AND SEWER PLAN AMENDMENT: TRACTOR SUPPLY COMPANY, CASE CWSP 10-200-003

Commissioner Russell opened the hearing at 10:45 am.

Mr. Chapman noted for the record that an announcement for Public Hearing was posted in the Enterprise on April 8 and 11, and property owners in the vicinity were notified by certified mail of the recommended change to the Comprehensive Water and Sewer Plan for the Tractor Supply Company.

PROPOSED ZONING TEXT AMENDMENT TO CHANGE USE TYPE 44, CAMPGROUND, FROM A CONDITIONAL USE TO A PERMITTED USE IN THE RURAL PRESERVATION DISTRICT AND COMMERCIAL MARINE DISTRICT FOR ESTABLISHMENTS OF 20 OR FEWER CAMPSITES (FIRST READING)

Present: Derick Berlage, Director, Dept. Land Use and Growth Management

Land Use and Growth Management staff presented their recommendations to streamline the review and approval process for property owners desiring to establish a campground or expand an existing campground. Staff suggested distinguishing between large and small campgrounds in the Ordinance and then regulating them differently depending on size. A small campground, 20 or fewer sites would be classified as a permitted use in the RPD and CM District and the larger campground containing more than 20 campsites would continue to be regulated as conditional use in the RPD and CM District. Staff is requesting the BOCC to accept the proposed amendment as a first reading, waive the 30 day comment period and second reading and direct the Planning Commission to proceed with a public hearing.

Commissioner Jarboe moved, seconded by Commissioner Morris, to accept the amendments as proposed for a first reading, waive the 30-day comment period and second reading required by Resolution 2005-03 and direct that the Planning Commission proceed with a public hearing and prepare a recommendation for the Board relating to the proposed amendments. Motion carried 4-0.

PROPOSED ZONING MAP AMENDMENT TO CORRECT AN ERROR PERTAINING TO THE CRITICAL AREA OVERLAY FOR BUZZ'S MARINA IN RIDGE (FIRST READING)

Present: Derick Berlage, Director, Dept. of Land Use and Growth Management

Mr. Berlage provided the background on the rezoning of the County and explained that in the case of Buzz's Marina, a mistake was made in drafting the zoning maps that were approved by the County

Commissioners and published as representing official zoning designations. An amendment is now required to correct the error and change the zoning from RCA to LDA

Commissioner Morgan moved, seconded by Commissioner Morris, to accept the zoning map amendment as proposed to correct an error pertaining to the Critical Area Overlay for Buzz's Marina for a first reading and direct that the Planning Commission proceed with a public hearing and prepare a recommendation for the Board relating to the proposed amendment. Motion carried 4-0.

PUBLIC HEARING ON THE ST. MARY'S COUNTY RECOMMENDED FY 2012 BUDGET

Commissioner President Russell provided welcoming remarks and commented on the budget process to date. Ms. Kramer stated that the notice of the evening's public hearing was published in the Enterprise on April 15, 2011. The final adoption of the FY 2012 Budget is scheduled for May 31, 2011. Any additional written comments relative to the FY 2012 Budget and Constant Yield Tax Rate must be submitted by May 6, 2011.

Constant Yield Property Tax Rate - Proposed Real Property Tax Decrease

Ms. Kramer presented the Board of County Commissioners' proposal to decrease real property taxes. For the tax year beginning July 1, 2011, the estimated real property assessable base will decrease by .4% from \$11,017,640,975 to \$10,969, 870,160. If St. Mary's County maintains the current tax rate of \$.857 per \$100 of assessment, real property tax revenues will decrease by .4% resulting in a \$409,396 reduction in real property tax revenues. In order to fully offset the effect of decreasing assessments, the real property tax rate could be increased to \$.8607, the constant yield tax rate. The County is not considering increasing its real property tax rate above the constant yield tax rate. The County proposes to adopt a real property tax rate of \$.857 per \$100 of assessment. This tax rate is .4% lower than the constant yield tax rate and will reduce property tax revenues by \$409,396.

Recommended FY2012 Budget

Ms. Kramer provided an overview of the Recommended FY2012 Budget. The recommended General Fund Budget is \$192,628,493, which is \$2,964,523 more than the approved FY2011 budget. This is comprised of revenue totaling \$191,945,882 a 3.6% increase of FY2011, as well as the application of \$682,611 in fund balance. Income tax and energy tax rates are proposed to stay the same as the previous year.

PUBLIC HEARING ON THE CONSTANT YIELD PROPERTY TAX RATE – PROPOSED REAL PROPERTY TAX DECREASE

Increase tax rate. County needs money. Bring in the additional \$409,000.

Dawn Pipkin, Hollywood MD 20636

Surprised with the proposal to lower the tax rate. Have seen reports that the County is 19th lowest in state for education. Cannot maintain services with lower tax rate. Urge you to consider constant yield.

Deb Rey, Lexington Park 20653

Thanked Commissioners for work on budget. All for maintaining tax rate. Surprised people want taxes raised. Keep tax rate the way it is today.

Parent and Volunteer in school system. Strong supporter of St. Mary's Schools. Support Para-educators 100% - they are driving force. 18-23 children in kindergarten children in class need extra help. How can you keep educators without para-educators? Para-educators are essential.

Mary Lusk, 39221 St. Thomas Dr. Mechanicsville, MD 20659

Support education. Have 2 children now in STEM program. In early years para-educators input was essential. Financial and academics attract high quality teachers and staff. Please fund budget submitted by Dr. Martirano.

Moved to St. Mary's County 2 years ago. Considered County school system when looking for new home. Concerned if you increase number of students in classes. More funding needed. Teacher. Went to school in St. Mary's County. Paid taxes for over 24 years. Proud parent of 2 children. Rigorous programs, qualified teachers and staff in school system. Need to increase funding. Is there funding available? Teachers help pay for supplies. Teachers make an influence on all children's lives. Release funding to schools.

Frank Guertler

Director at College of Southern Maryland. Concerned with Tech Center welding class, heard someone say might be canceling class. What happens if teacher retires – do classes end. Lack of talent versus lack of jobs. Need to start children for trades in high school. As you evaluate and look at education, look at trades, without infrastructure we fail.

Kim Belvin

Parent, Volunteer, Advocate for students in St. Mary's County schools. When the doors opened tonight people most affected cannot be here, they are at sports practice, doing home work and getting ready for bed. Adults are here to find way to secure their future and set

them up to succeed. Kids want to stay in St. Mary's County; they are watching to see if you invest in them. Fund higher education - task is not a big one.

Donald Wergard

2nd grade Student at Evergreen. Want funding so teachers can keep their jobs. We have great teachers who need to keep their jobs.

Madison Morgan

3rd grade Teacher. Introduced mothers who held pictures of their children while Ms. Morgan explained their success stories. Success stories might not be possible if you cut 2 instructional teachers to 1. Need IRT teachers in large classes. What will happen to children who need extra support if class size increases and IRT teachers cut? Budget cuts will rob student's quality of education in our community.

Dr. Donald Taylor, Waldorf, MD

Spends 2 hrs a week working at Marcey House. Read letter from Commissioners. Substance Abuse program, psycho education program will not see continuous improvement without funding. There is an aggressive prudent medicine available that requires a specialist to administer and a specialist is not available on a daily basis to do so. Clients need diagnostic treatment. Fifteen percent of those being treated would otherwise be in jail if it weren't for Marcey House. Pay now or pay later with interest.

<u>Dr. Michael Martirano, Superintendent, Saint Mary's County Public Schools, Moakley Street, Leonardtown MD 20650</u>

Taxpayer. 2 children in school. Represents 2,300 employees, 35,000 parents. Students receive world class education. Thanked every individual who sent email and letters. January budget had 14.2M deficit. We continue working with precision. The school board has not received their budget from the state. Working tirelessly and continuously to address budget issues. \$1.9M is up for discussion. Need funds to eliminate further staff reductions. Needs dialog between two boards to discuss ways to find a balance. Asked Commissioners for their support. We've done our part now you do your part.

Pat Carney, Leonardtown, MD 20650

Asked Commissioners to consider Social Services. Department's Budget has been cut drastically. Department serves those in most need; those who are not concerned with FY12 or 13, those who are trying to make it through the present day. Consider these individuals. No group should monopolize the budget.

Marguerite Morris, P. O. Box 203, Callaway MD 20620

Representing Leah's House. Homeless shelter for women and children. Five times I have come and asked for funds and have never received any. St. Mary's County sends funds in Calvert and Charles County. Need to keep St. Mary's County residents employed. Need \$15,000 a month to house, feed, pay utilities, and transportation. Janice Walthour, 45811 Delegates Ct., Great Mills, MD 20634

As a member of NAACP, I can attest to the inequities that many minorities are experiencing in this county. Not meeting the needs of the minority population in our communities or our schools. We have 2 St. Mary's Counties – households earning salaries of \$80,000 and above and households earning \$50,000 and below. A large percentage of African Americans and Hispanics fall below the \$50,000 mark and are faced with obstacles and challenges promoted by the local bureaucracy. Lower income families have been relegated to Lexington Park. Most schools in the area are doing well but the high school in Lexington Park district has a graduation rate range between 76% to 83%. In 2009 and 2010 only 69% of African-American males graduated from Great Mills High School. We pay more to incarcerate than educate. Schools going out begging. Minority teachers represent 9% of teaching staff; student population is more than 21% minorities. I implore you, please be good stewards to all of the people. For the record a handout of complete remarks was presented to Commissioners.

Elfreda Mathias, 45811 Delegates Ct., Great Mills, MD 20634

Should have stuck to the old plan of 3% instead 10%. Military mission is driver of the County. They look at what type of schools we have and type of community to raise a family.
