#### CALL TO ORDER

Meeting called to order @8:35a.m. by President Barbara McWilliams with the following **Board Members present**: Pat Friend, John Madel, Eleanor Slater, Dale Springer, Laura Wigginton, James Banagan, George Kennett, and Barbara McWilliams.

The USCG gave an addendum for the Water Taxi to operate through June regarding the number of occupants allowed versus type/size vessel. The Water Taxi is already scheduled for April school groups.

Debra also stated that entrance fees (esp. @ PPLH) may need to increase in the future.

#### FRIENDS UPDATE

Dale Springer advised that the annual meeting was held on March 1st. Member fees will increase with the Fall renewals. Financial matters are good but membership efforts need to be expanded. A membership committee needs to be formed to improve membership numbers and review fees. They may discontinue the Senior membership level. The Friends goal for membership is a 20% increase.
