ENCUMBRANCE VOUCHERS

Commissioner Arnold moved, seconded by Commissioner Sayre, to approve payment of the bills as submitted by the Director of Finance. All Commissioners present voted in favor.

APPROVAL OF MINUTES

Commissioner Dean moved, seconded by Commissioner Arnold to approve the minutes of the Commissioners' meeting of September 19, 1979. All Commissioners present voted in favor.

EMPLOYEES ASSOCIATION

Present: Gene Pellillo, Vice-President

Mr. Pellillo advised the Commissioners that the Employees' Association would like to use some of the funds in the Association treasury to place flowers and shrubbery around the sign and flagpole on the Governmental Center grounds at a cost of approximately \$250. The Commissioners gave their concurrence.

PROCLAMATION NO. 79-62 "TRICK OR TREAT DAY"

The Commissioners signed and approved the referenced Proclamation designating Wednesday, October 31, 1979 as the County's official "Trick or Treat Day".

UPDATE ON CETA POSITION

The County Administrator presented a memorandum from the Personnel Officer bringing the Commissioners up-to-date regarding the CETA phasedown as of September 28, 1979.

OFFICE OF CIVIL DEFENSE COMMUNICATIONS OPERATOR I

The County Administrator presented a memorandum from the Personnel Officer requesting authorization to begin the established selection process for the Communications Operator I position, Grade 8, vacated by Shirley Pederson.

Commissioner Arnold moved, seconded by Commissioner Dean to begin the procedure for the filling of this vacancy.

NOTIFICATION OF GRANT AWARD - COMMISSION ON AGING

The County Administrator advised the Commissioners that the State Office on Aging by correspondence dated September 28, 1979 submitted the revised Notification of Grant Award which changes the grant period for FY 1980 for the Title III-C Grant so that it will coincide with the federal fiscal year.

Commissioner Dean moved, seconded by Commissioner Arnold, to authorize Commission President Aud to sign said NGA. All Commissioners present voted in favor.

FORFEITURE OF FUNDS

The County Administrator presented correspondence from Joseph Densford, Assistant County Attorney, dated September 21, 1979 regarding settlement of forfeiture of funds as contraband in a drug-related case (Daniel Eugene Love) and requested authority from the Commissioners to proceed with this settlement. The Commissioners gave their concurrence.

SPRING VALLEY SUBDIVISION (CORONADO VILLAGE) PUBLIC WORKS ADDENDUM NO. III

The County Administrator presented correspondence from Maryland National Bank dated September 28, 1979 with Addendum No. III requesting an extension of time from October 14, 1979 to December 1, 1979 for the completion of streets in Section 3 of Spring Valley Subdivision (Coronado Village). It was the recommendation of the County Engineer that this extension be granted. The Commissioners gave their concurrence.

LEXINGTON PARK VOLUNTEER RESCUE SQUAD ONE-TIME LOAN PAYBACK

The County Administrator reviewed correspondence from the Lexington Park Volunteer Rescue Squad with the Commissioners requesting an installment method of payment over five years of \$2,400 per year. The Commissioners agreed with this proposal stating that the first yearly repayment begin immediately.

SOUTHAMPTON SUBDIVISION

By way of correspondence dated September 24, 1979, Mr. Joseph Weiner informed the Commissioners that negotiations are proceeding relative to the purchase by the federal government of the Southampton property owned by Mr. Weiner. Since the federal government is exempt from payment of local property taxes, Mr. Weiner requested that he be responsible for only that portion of the FY 79-80 property taxes up to the time of settlement.

The Commissioners gave their concurrance.

LEONARDTOWN POST - MARYLAND STATE POLICE BARRACKS

The County Administrator reviewed with the Commissioners the plans for the new Maryland State Police barracks to be located on the Leonard Hall property. The Commissioners gave their concurrence to the plans and requested the County Administrator to prepare correspondence to the State Police reiterating the Commissioners' opinion that there be only one central communications center and it should continue to be located at the Emergency Operations Center.

ACCOUNT TRANSFER MEMORY TYPEWRITER OFFICE OF PLANNING AND ZONING

The County Administrator presented a request from the Office of Planning and Zoning for the purchase of the IBM Memory Typewriter with account transfers as follows:

The Commissioners gave their concurrence to approve this account transfer.

RESIDENT MAINTENANCE ENGINEER REPORT

President: William Lacey, Highway Maintenance Engineer, SHA

On behalf of Mr. John D. Raley, Resident Maintenance Engineer, Mr. Lacey appeared before the Commissioners to give the progress report on road and drainage problems as presented at previous Commissioners' meetings and further to obtain additional concerns from the Commissioners.

ZONING VIOLATIONS

Present: Frank Gerred, Director, Planning and Zoning

Mr. Gerred advised the Commissioners of several zoning violations and requested the Commissioners' direction as follows:

Zoning Violation #1 - An individual who requested a Conditional Use from the Board of Appeals for a home occupancy. He has not complied with the parking requirements and has been ordered by the Board of Appeals to discontinue until he does comply. The Commissioners directed that legal action be taken if the individual does not come into compliance.

Zoning Violation #2 - An individual has built a storage shed without a building permit and is also in violation of the side yard setback requirement. The property owner has not accepted Certified Letters that have been sent to him requesting that he come in to work out a solution. The Commissioners directed that Mr. Gerred continue to try to arrive at a solution with this individual and if not proceed with legal action.

Zoning Violations #3(a) and (b) - Mr. Gerred stated that there are two mobile home parks that have gotten behind in paying their fees. The Commissioners directed that Mr. Gerred proceed with legal action.

Zoning Violation #4 - Mr. Gerred advised that a mobile home never got a building permit. The Commissioners requested Mr. Gerred to try to work out a solution to this violation.

VICTORY BAPTIST CHURCH SCHOOL

Mr. Gerred advised the Commissioners that water samples taken from the Victory Baptist Church School show contamination. The water is being chlorinated and will be tested again. Mr. Gerred recommended that if the water samples come back unsatisfactory that action be taken to remove the school from the site. The Commissioners gave their concurrence.

LORD CALVERT TRAILER PARK FHA 207 PROGRAM

Mr. Waring advised the Commissioners that he has made application in conjunction with the development of an additional section of Lord Calvert Trailer Park to the FHA 207 Program. Mr. Waring stated that because of insurance problems based on the fact that the only employer in the areas was the Naval Air Station and this decision has been appealed in that the wrong rules and regulations were applied in this case.

Mr. Waring advised that there are almost no trailer pads available in the County today and there is a tremendous demand for it for low to moderate income families.

Mr. Waring stated that as part of his application for the 207 Program he would need a letter from the Board of County Commissioners endorsing the concept of this project as being necessary and viable for St. Mary's County and that the County would like to see FHA participate in this guarantee.

The Commissioners gave their concurrence and requested the County Administrator to draft a letter for their review.

LORD CALVERT TRAILER PARK REQUEST FOR EXEMPTION OF FEES

REZONING HEARING

CASE NO. ZA 79-117

JAMES DOBRY & DOBRY CONSTRUCTION CO., INC.

Ayscue, Case No. ZA 79-19, to have approximately one acre of land located on Rte. 5, Mechanicsville, Fifth Election District, rezoned from AR-2, Agricultural-Residential, to Commercial, C-2, said acre being a part of Parcel 41, Tax Map 4. All Commissioners present voted in favor.

ZONING DECISION RESOLUTION NO. Z 79-09 MARY MARTHA BROOKS - CASE NO. ZA79-75

Rte. 247, in the Sixth Election District known as Parcel 20 on Tax Map 19, rezoned from AR-2, Agricultural-Residential, to R-2, Low Density Urban Residential. All Commissioners present voted in favor.

In addition, the Airport Committee members stated that there is an operator at the Airport during the interim until a Fixed Based Operator is hired and authority is needed from the Commissioners to allow the interim operator to purchase gas.

The Commissioners agreed to sign and forward the letter and further to grant authority for the interim operator to purchase gasoline in order to keep the Airport functioning.

RIGHT-OF-WAY EASEMENT

On behalf of the County Engineer, the County Administrator presented a request from the Trustee of the property to effect an Easement over the County railroad right in Fifth Election District, near the Charles County line off of Rt. 5.

Commissioner Dean moved, seconded by Commissioner Sayre to authorize Commissioner President Aud to sign said Easement Agreement dated October 3, 1979 by and between St. Mary's County Commissioners, Southern Maryland Electric, Cooperative, Inc. and Paul J. Bailey, Trustee. Three Commissioners present voted in favor, with Commissioner Arnold abstaining because of possible conflict of interest since he may be auctioneer for the petition sale of this property.
