## PLANNING AND ZONING

Modified Industrial Site Plan Wildewood Technology Lot No. 8 File No. STSP 86-0650

Present: Frank Gerred, Director, Planning and Zoning Robin Guyther, Planner

Mr. Guyther presented for appoval a modified industrial site plan for CDSI in the Wildewood Technological Park which met with planning and zoning approval for a permit to add 4,993 square feet to the original 15,000 square feet which was previously approved by the planning commission. Commissioner Bailey moved, seconded by Commissioner Lancaster giving approval for the modified industrial site plan. Motion carried.

# Comprehensive Land Use Plan Process

Present: Jeff Jackman, Land Use Planner

Mr. Jackman presented to the Board of County Commissioners to plan procedures necessary for the Comprehensive Land Use Plan. He noted that the deadline for the draft for the local critical areas program to be submitted to Annapolis is August, 1987. mr. Jackman continued, discussing the comprehensive plan process the critical areas, and budget.

## Comprehensive Land Use Moratorium

Present: Frank Gerred, Director, Planning & Zoning

Mr. Gerred recommended to the Board that the county should temporarily halt all rezonings while the comprehensive land use plan is being established. Mr. Gerred explained that it takes approximately six to nine months for the rezoning process to be completed. The comprehensive plan should e completed within the next year, thus, the rezoning moratorium should be approved to not allow any more changes in order for better planning purposes. Commissioner O'Dell asked Mr. Gerred to do an assessment of rezoning requests and return to the Board for a final decision after Planning Commission review and recommendations.

## DEPARTMENT OF RECREATION AND PARKS

Wicomico Shores Golf Course and Country Club Status Report

Present: John V. Baggett, Director, Recreation & Parks Joseph R. Densford, Assistant County Attorney

Mr. Baggett opened his status report stating that he thinks the offer is a recreational benefit to the county and should be preserved for future generations as a public facility. The areas discussed included stormwater management, legal transfer of shares from Chaptico Recreation Corporation to the county of facilities and conveyance of golf carts. Staff salaries and the contract with the Golf Pro were also discussed. Attorney Densford said he feels the county is legally bound to keep the contract with the Golf Pro which runs from October, 1986 to October, 1987. Outstanding bills at the time of property transfer are the county's debt. Repairing the pool was reported as possibly a large undertaking.

Commissioner Bailey moved, seconded by Commissioner Jarboe to establish the Chaptico Recreation Corporation Fund, leaving the corporation basically intact until the County Commissioner appointed Board of Directors comes back with definitive recommendations. In addition, the Board of Directors will direct the money through the fiscal procedures of the county. Motion carried.

Commissioner Jarboe moved, seconded by Commissioner Bailey to establish a bank account on behalf of the Chaptico Recreation Corporation and authorize the President and Treasurer of the Board of Directors to open the bank account and sign checks to pay bills. Motion unanimously carried.

There was unanimous agreement that a revenue and expense statement should be prepared on a monthly basis.

Mr. Baggett and Mr. Densford were asked to do an analysis of the facility and return to the Board on January 13, 1986 with a completed status report for review.

The morning session concluded at 12:35 p.m. The afternoon session began at 1:25 p.m.

#### OFFICE ON AGING

Overview of Office on Aging Problems

Present: Agnes C. McGaharn, Director of Office on Aging

Ms. McGaharn stated that the catalyst for the services for the county's elderly began in 1974. She then presented an organizational chart, explained their areas of operation and budget, and noted that the grants from the state assisted in the operation of Titles III, B - Transportation, C1 - Congregate Food, C2 - Home Delivered Meals, Gateway I - In-Home Care, Gateway II - Long-term Care.

Ms. McGaharn stated that goals for 1987 are to strengthen the following areas:

- A. Intensive training for personnel
- B. Obtain an outreach worker
- C. Obtain a Senior Center manager
- D. Increase hours of Senior Center use more evenings and week-ends
- E. Schedule more consistent approach to nutrition
- F. More consistent exercise program

Ms. McGaharn said there is ten percent participation in the programs by the elderly.

## COUNTY ADMINISTRATOR ITEMS

# Sewerage Disposal from Boating Public

The County Administrator presented correspondence from Mr. Frank Gerred dated November 19, 1986 regarding marina rules and regulations which addressed the problem of sewerage disposal from the boating public. Mr. Gerred suggested that the county establish a task force to assess and solve the pollution problem.

The Board of County Commissioners requested that Mr. Gerred appear before them for discussion and explanation of the matter before a decision can be made regarding a task force.

County Facility for Department of Motor Vehicles

Commissioner Jarboe stated that citizens have asked him the status of the Department Motor Vehicles rendering their services to the county. The County Administrator explained that the Felix Johnson building in Lexington Park is available and awaiting a decision by the Department of Motor Vehicles to reestablish their services to this area.

The Board of County Commissioners will take into consideration requests for leave for county employees on January 2, 1987 and return their decision on December 30, 1986.
