# APPROVAL OF MINUTES

Commissioner Bailey, moved, seconded by Commissioner Lancaster, to approve the minutes of the Commissioners' meeting of Tuesday, September 27, 1988. Motion carried.

#### ST. MARY'S DAY CARE CENTER

As a follow up to last week's discussion, Mr. Mitchell presented an Agreement between St. Mary's Hospital and St. Mary's County for a child day care center to be located on the hospital property. Community Development Block Grant funds in the amount of \$98,000 from HUD through the State are being used towards the cost of construction. The hospital is responsible for construction and operation of the facility, which will provide child day care for low to moderate income families.

After discussion Commissioner Bailey moved, seconded by Commissioner Lancaster, to authorize Commissioner Loffler to sign the Agreement, which has been reviewed and recommended for approval by the Hospital Board and Assistant County Attorney. Motion carried.

# OFFICE OF PLANNING AND ZONING PUBLIC HEARING

Mr. Guyther read the Notice of Public Hearing aloud, as advertised in The Enterprise Newspaper on September 14, 1988 and September 21, 1988, a publication of county-wide circulation, providing legal notice for the following public hearing:

# SPEC # 87-2004: LEONARDTOWN CENTRE

Requesting a change in the Water and Sewer Plan categories from W4D and S4D to W2D and S2D to allow connection to the existing systems. The property is located on the west side of Rt. 5 just north of Leonardtown. Shown on Tax Map 32, Block 15 as Parcel 328.

Mr. Guyther noted that the category changes were necessary to allow the applicant to connect with the existing systems. He explained that Mr. King of the Metropolitan Commission, had recommended the changes be from W4D and S4D to W1D and S1D and that the Planning Commission had recommended approval.

Commissioner Loffler inquired whether anyone present wished to speak either in favor or in opposition. No comment being offered, the hearing was closed.

Commissioner Jarboe moved, seconded by Commissioner Bailey, and unanimously passed, to approve the water and sewer changes as recommended by the Planning Commission and the Metropolitan Commission.

# 1) LEASE AGREEMENT STORAGE SPACE - LIGHTHOUSE ROAD

As a follow up to previous discussions regarding S.M.I.L.E. coming under the administration of County Government, Commissioner Thompson moved, seconded by Commissioner Lancaster, and motion carried to:

To authorize Commissioner Loffler to sign letters to the Coordinator of Adult Day Care and the Coordinator for community Program notifying them of the transfer of S.M.I.L.E to County Government on October 31, 1988;

To approve that:

The existing cash in the S.M.I.L.E. account representing program income will be transferred to the County on October 31, 1988;

The financial records will be turned over to the Finance Office on or before October 31, 1988;

The Office of Aging be authorized to submit the existing S.M.I.L.E. positions to the Personnel Office for classification under the county system;

The Development of a revised budget for the day care program in the Office on Aging reflecting administration of the program for the county.

Commissioner Thompson further moved, seconded by Commissioner Lancaster, to establish the S.M.I.L.E. Board of Directors as an advisory council, develop bylaws for S.M.I.L.E. and to revise bylaws for Commission on Aging and submit them to the Commissioners. Commissioner Jarboe voted against the motion stating that instead of two boards, the Commission on Aging should be expanded to include some of the S.M.I.L.E. Board members. Motion carried four to one.

#### GRIEVANCE PROCEDURES - PURDY

As a follow up to last week's presentation of the the Purdy grievance procedures, the Commissioners discussed the next steps to be taken. In that the Sgt. Purdy had contacted some of the Commissioners to request an appearance before the Board, the Commissioners agreed to schedule him on next week's agenda. In response to an inquiry from Commissioner Loffler, Ms. Manson advised that it is permissable and appropriate for the Commissioners to meet with the aggrieved party, and that this would not constitute a reopening of a hearing. She stated that the Personnel Manual gives the Commissioners the prerogative to conduct a new hearing if they so desire.

In conclusion the Commissioners requested Ms. Manson to notify Lt. Purdy to put his request to appear before the Board in writing and that it will be scheduled next week.
