2) CORRESPONDENCE HIGH SCHOOL BAND/SCHOOL FUNDING

The County Administrator presented the following items of correspondence:

To Rhonda Sadler explaining why Great Mills Band did not march in the homecoming parade and addressing her concerns regarding funding of school bands.

To Amy Wilson responding to her concerns about school funding and explaining the County's budget process for the Board of Education.

The Commissioners agreed to sign and forward the letters.

3) 1990 LEGISLATIVE ITEMS

The County Administrator presented correspondence to the Office of Community Services advising that the legislative requests for: Child Care Centers - Start Up Funds; Child Care Providers - Salaries; and Family and Medical Leave do not need legislative action and suggesting that they would best be handled administratively by appropriate state or federal agency.

The Commissioners agreed to sign and forward the letter.

4) LEONARD HALL DRILL HALL DAY CARE CENTER PROPOSAL

The County Administrator presented correspondence addressed to the Head Master of Leonard Hall School responding to her request to amend the Lease with the County in order to allow operation of a day care facility at the drill hall. The letter advises that the Commissioners denied the request indicating that it is contrary to the fundamental understanding of the Lease.

The Commissioners agreed to sign and forward the letter.

5) REQUEST FOR WAIVER OF IMPACT FEE

The County Administrator presented correspondence addressed Francis K. Abell of McCrone, Inc. responding favorably to his request for waiver of impact fee because the Town and Mr. Abell were unaware at that time of the fee. Mr. Cox indicated that this is the only case in this situation and that all others will pay the fee.

The Commissioners gave their concurrence.

6) NAVAL AIR STATION EXECUTIVE SESSION ISSUES

The County Administrator presented correspondence addressed to the Commanding Officer of the Naval Air Station suggesting an Executive Session with the Commissioners to discuss the following issues: North End Gate, Frank Knox School, Felix Johnson School, Former Center Gardens property, Elementary School site, Property needed by Metropolitan Commission.

The Commissioners agreed to sign and forward the letter.

7) SOUTHERN MARYLAND ELECTRIC BONDING REQUIREMENTS

The County Administrator presented correspondence addressed to Wayne Swann responding to SMECO's request to waive bonding requirements for projects within St. Mary's County. The letter states that it is not in the County's best interest to grant a general waiver; however, the County would be willing to consider requests on a case-by-case basis.

The Commissioners agreed to sign and forward the letter.

8) TRAPPING OF BEAVERS

The County Administrator presented correspondence addressed to Mr. Thomas a. Beach indicating that the Department of Natural Resources is of the opinion that trapping during established seasons is good conservation practice and that he should be allowed to trap beavers in the vicinity of the Airport and Route 235 conditioned by monitoring of DNR.

Commissioner Lancaster moved, seconded by Commissioner Jarboe, to sign and forward the letter as presented. Motion carried.

9) ECONOMIC DEVELOPMENT COMMISSION COMPREHENSIVE PLAN/ZONING ORDINANCE

St. Mary's Industrial Park (Rodney Thompson) - Correspondence to Maryland Bank and Trust Company calling Letter of Credit No. 263 in the amount of \$18,000 for Grading Permit No. 88-41.

Commissioner Lancaster moved, seconded by Commissioner Jarboe, to authorize Commissioner Loffler to sign the correspondence calling referenced letters of credit. Motion carried.

2) PUBLIC WORKS AGREEMENT COMMERCE PARK ROAD

The County Administrator presented a Public Works Agreement between Edward B. Howlin, Inc. and St. Mary's County guaranteeing completion of Commerce Park Road by September 15, 1990. The Agreement is backed by a Letter of Credit with Maryland National Bank in the amount of \$33,500.

3) SETTLEMENT AGREEMENT NATIONAL MOBILE HOMES (HEWITTS ROAD PROJECT)

4) TALL TIMBERS SHORE EROSION CONTROL DISTRICT AGREEMENT

The County Administrator presented the Tall Timbers Shore Erosion Control District Grant Agreement in the amount of \$133,650 with the Department of Natural Resources.
