### APPROVAL OF MINUTES

Commissioner Jarboe moved, seconded by Commissioner Thompson, to approve the minutes of the Commissioners' meeting of Tuesday, November 21, 1989. Motion carried.

### APPROVAL OF BILLS

Commissioner Lancaster moved, seconded by Commissioner Thompson, to approve payment of the bills as presented. Motion carried.

#### DRUG FREE SCHOOLS AND COMMUNITY PROGRAM

Present: Judy Landau, Alliance Public Relations

Ms. Landau appeared before the Commissioners to present a grant application under the Drug Free Schools and Communities Program in the amount of \$150,000 to be submitted to the U. S. Department of Education. Ms. Landau indicated that a drug free school and rural community broadcast project for students 6 - 8 and their parents is proposed to be implemented. Channel 52, the new station in Leonardtown is willing to cooperate in having groups appear on television, and other programs are being planned.

After discussion Commissioner Jarboe moved, seconded by Commissioner Lancaster, to authorize Commissioner Loffler to sign the grant application as presented. Motion carried.

#### COUNTY ADMINISTRATOR ITEMS

# 1) BRETON BAY PLANNED UNIT DEVELOPMENT ROAD AND ENTRANCE CONSTRUCTION

The County Administrator presented correspondence to the President of the Breton Bay Recreation, Inc. responding to his November 7 letter regarding review fees, grading permit fees, and county participation in correcting road and entrance construction. The correspondence indicates that the county is willing to participate in the road and entrance improvements and the details will be developed and coordinated between the Association and Department of Public Works. The letter further indicates that the County cannot approve the the request to waiver or rebate fees because they are based on the principle of the users of services paying for them rather than the general public.

The Commissioners agreed to sign and forward the letter.

# 2) CLEARINGHOUSE PROJECT NO. MD891127-0897 EXCESS PROPERTY (LANDLOCKED) - NORTH OF PATUXENT BEACH ROAD

The County Administrator presented the referenced clearinghouse project and recommended indicating to the State that the County has no need for that property and that it can be offered for public sale.

After discussion, Commissioner Thompson moved, seconded by Commissioner Lancaster, to accept the County Administrator's recommendation. Motion carried.

# 3) CAPITAL PROJECT GRANT APPLICATION ST. MARY'S COUNTY REGIONAL PARK

On behalf of the Director of Recreation and Parks, the County Administrator presented the referenced Grant Application in the amount of \$3,000,000 based on Senate Bill No. 702 of 1989. The County will participate with the State on a 50%-50% basis.

Commissioner Thompson moved, seconded by Commissioner Lancaster, to approve and authorize Commissioner Loffler to sign the grant application as presented. Motion carried.

### 5) PROPERTY MANAGEMENT PROCEDURES AND REGULATIONS MANUAL

The County Administrator presented a memorandum from the Procurement Officer forwarding the referenced procedures and regulations manual, which will be the county's inventory control process. The manual has been reviewed by the Commissioners and department heads, and no negative comments have been received.

After discussion Commissioner Lancaster moved, seconded by Commissioner Bailey, to approval and sign the manual as presented. Motion carried.

### 7) GRANT AWARD SIERRA HOUSE

The County Administrator presented the Notification of Grant Award in the amount of \$129,184 from the Alcohol and Drug Abuse Administration for the Sierra House.

Commissioner Thompson moved, seconded by Commissioner Lancaster, to authorize Commissioner Loffler to sign the Condition of Grant Award Statement and Assurance of Compliance with Title VI of the Civil Rights Act of 1964. Motion carried.

# 8) PROCESSING HEALTH DEPARTMENT INVOICES

The County Administrator presented a memorandum dated November 28 from the Director of Finance indicating that Dr. Marek, St. Mary's County Health Officer, has requested that the County process all of their invoices for payment. This request is made because the State's system of payment is lengthy and laborious and has caused concern to local vendors. The Director of Finance has indicated that this would not be an additional burden and recommended that the county handle the Health Department's invoices.

Commissioner Lancaster moved, seconded by Commissioner Jarboe, to accept this recommendation. Motion carried.

# 9) LEGISLATIVE PACKAGE ITEMS

The County Administrator presented the following items to be added to the County's 1990 Legislative Package:

- Property Article of the Maryland Annotated Code, the Commissioners adopted an Ordinance which raised the interest charge to one (1%) percent and the penalty charge to three (3%) and is now Section 267-5 of the Code of St. Mary's County. Under Section 139-2 of the County Code, the interest rate is two thirds of one (2/3 of 1%) percent. Therefore, the County Administrator presented correspondence requesting the legislators to delete Section 139-2, B since it is in conflict with Section 267-5.
- o Item No. 26 Eminent Domain St. Mary's County does not have the privilege of eminent domain as do certain other counties. Delegate Bell has recommended that the County apply for that privilege during the 1990 Legislative Session. Therefore, the County Administrator presented correspondence to the legislative delegation requesting that it be included in the County's legislative package.

After discussion Commissioner Thompson moved, seconded by Commissioner Lancaster, to approve and sign correspondence regarding Item No. 25 - Interest and Penalty. Motion carried.

Item No. 26 - Eminent Domain will be held until next week's meeting.

# 10) BUDGET AMENDMENT NO. 90-22 COUNTY ADMINISTRATOR

The County Administrator presented the referenced Budget Amendment for funds to purchase an automatic validating machine to be used for the County Commissioners' Mail Log.

Commissioner Thompson moved, seconded by Commissioner Lancaster, to approve and authorize Commissioner Loffler to sign the Budget Amendment as presented. Motion carried.

# 11) REQUEST FOR INCREASED APPROPRIATION SOTTERLEY MANOR

The County Administrator advised that the Sotterly Foundation has requested an additional appropriation in the amount of \$13,000 from the current year's budget for preservation of the deteriorating barn at Sotterly Manor. The Director of Finance by memorandum dated November 28 advised that the County has no indication of the financial condition of the Sotterly Foundation or what actions have been taken to become self-supporting and recommended not approving the request.

After discussion the Commissioners requested that correspondence be prepared to the Sotterly Foundation requesting a clarification of how funds are being spent, costs for preservation of the barn, and an accounting of the Foundation prior to the Commissioners making a decision.

# 12) "INNER CAMPUS" CHARLES COUNTY COMMUNITY COLLEGE

The County Administrator advised that correspondence had been received from Tri-County Council forwarding a proposed letter to Governor Scheafer requesting assistance in securing State funding for the construction of the "Inner Campus" of the Charles County Community College. The letter includes a caveat stating that St. Mary's County is also planning a community college structure and the state funding is not intended as a substitution.

After discussion Commissioner Lancaster moved, seconded by Commissioner Jarboe, to endorse the proposed correspondence which will be prepared by Tri-County Council for signatures of the Commissioners and Legislators of the three southern Maryland counties. Motion carried.

# RESOLUTION NO. 89-31 BOARD OF EDUCATION CAPITAL IMPROVEMENT PROGRAM FISCAL YEAR 1991

As a follow up to Board of Education's presentation of the Capital Improvement Program, the County Administrator presented the referenced Resolution.

After discussion Commissioner Lancaster moved, seconded by Commissioner Thompson, to approve and sign Resolution No. 89-31 as submitted. Commissioner Jarboe voted against stating that he would not support it in that it did not use the old formula for class sizes. Motion carried three to one.

Commissioner Bailey moved, seconded by Commissioner Jarboe, to approve the appointment of the individuals as referenced. Motion carried.

### 1) SNOW REMOVAL PLANS

The referenced individuals appeared before the Commissioners to present and review the <u>Snow Emergency Plan for County Government Buildings</u> and the <u>Snow and Ice Control Operational Plan Copies of the Plans are on file in the Commissioners' Office.</u>

Also presented was a cost summary of the November 22 snow storm which totalled \$21,747.

### 2) PEGG'S ROAD

Mr. Ichniowski requested approval to schedule a public hearing for the route selection for Phase Two of the Pegg's Road Project for January 3, 1990. During discussion he distributed the handout for the January 3 meeting which provides the agenda, background information and maps.

The Commissioners gave their concurrence for Mr. Ichniowski to proceed with the public hearing.

### 3) ISLAND CREEK - FEDERAL NAVIGATION PROJECT

Mr. Ichniowski presented a Waterway Improvement Fund Grant Application for construction of a 1200 foot stone jetty along the southern side of the Island Creek Channel. Total project cost is \$1,609,700 with costing sharing (Federal - 80%; Local \$322,000) State may pay full local share if eligible, and \$92,000 has been approved by the State and will be available after July 1.

After discussion Commissioner Thompson moved, seconded by Commissioner Lancaster, to approve and authorize Commissioner Loffler to sign the grant application as presented. Motion carried.

OFFICE OF PLANNING AND ZONING

AGRICULTURAL LAND PRESERVATION DISTRICT

ALPD #84-0702/83-1231 - OLIVER GUYTHER

Mr. Marsh presented the referenced application for an ALPD which is a re-application for the sale of development rights easement which the County reviewed and approved in Fiscal Year 1986. At that time the applicant rejected the foundation's offer and now wishes to be reconsidered for the Fiscal year 1990 Acquisition Program.

Mr. Marsh indicated that the staff, Agriculture Preservation Advisory Board, and Planning Commission have recommended approval.

After discussion Commissioner Jarboe moved, seconded by Commissioner Lancaster to approve the application as presented. Motion carried.

It has been difficult to get a quorum, and therefore, Tri-County Council staff has had to implement the program without input from the committee on many occasions. She stated that a regional tourism program and budget is due to be submitted to the County in three weeks, and because of membership difficulties in Charles and Calvert Counties, this may not be possible.

After discussion of the situation, the Commissioners requested the Committee to provide the Board with alternative solutions as well as a proposed program and budget for their consideration.
