Residents of the communities of St. Joseph's Project and King Kennedy explained to the Commissioners the problems they have experienced with open-air drug markets and their respective efforts to counteract the problems. They were supported in their testimony by State's Attorney Dorsey and Sheriff Pettit.

The residents requested the County's cooperation in the placement of street lights in order to lessen the likelihood of the reoccurrence of the open-air drug markets. Director of Public Works Ichniowski explained the county's street lighting policy and provided a information sheet demonstrating the required number of light for those communities, the installation costs, and the annual user fee.

Because of the delay caused by obtaining the requisite number of signatures for the petition for street lights to establish a special taxing district, it was suggested by the Commissioners to fund the installation and related costs for the first year of operation and requested the citizens to continue to obtain the required signatures for petition for the special taxing district, after which establishment the citizens would absorb the operating cost of the second and succeeding years.

After discussion Commissioner Bailey moved, seconded by Commissioner Lancaster, to allocate \$5650 for installation and and the first year's operating costs of the street lights for King Kennedy and St. Joseph's project. Motion carried.

The citizens agreed with this approach and accepted the responsibility to proceed with the petition.

1) REZONING DISCUSSIONS/DECISIONS

CSUB 389-1877 - HAYDEN'S RUNN CLUSTER SUBDIVISION

Also Present: Donald Ocker, Norris, Gass & Ocker Engineering

Requesting concept review for cluster subdivision for 66 lots and recommendation for water category change from W-6 to W-3D for 199.842 acres, zoned AR/RPD, located on Chaptico-Mechanicsville Road south of Beverly Estates; Tax Map 12, Block 23, Parcel 30.

The public hearing on this case was held on Tuesday, July 17, 1990 and evidence and testimony received. Mr. Meinert provided the history of this application and noted that the request before the Board was for change in the water category which would allow the subdivision application to proceed through appropriate channels for further technical review. Both the Health Department and the Metropolitan Commission have reviewed the category change request and have given favorable recommendations. The Planning Commission considered the water category change request on June 11, 1990 and recommended approval. Staff's recommendation was positive.

Commissioner Bailey moved, seconded by Commissioner Thompson to grant approval of the water category change from W-6 to W-3D for this 199.842 acre parcel, zoned AR/RPD. Motion passed unanimously.

ZPUD 390-0444 - OAK CREST CENTER

Requesting rezoning form I-1 top PD-IP for 146.54 acres
located off of Md. Rt. 235 across from Wildewood, Tax
Map 34, Block 10, Parcel 292.

The public hearing on this rezoning matter was previously held by the Board of County Commissioners on July 17, 1990, at which time documentary evidence and testimony was received. Mr. Meinert provided the particulars of the rezoning application, noting that the applicant had provided a revised plan which addressed a number of staff's former comments. Staff advised that the previous concerns of the Planning Commission identified numerous environmental issues and other site design issues which could be addressed through the site plan approval process which would occur through the PUD approval.

SMEISTER BALLONS

An addendum to the Staff Report offering additional information was distributed to the Commissioners which related to two issues: (a) noise abatement; and (b) physical separation of the development pods within the PD-IP form adjoining properties.

Mr. Meinert noted that this property was almost entirely surrounded by property that would be within zones residential and therefore, staff would request protection from noise impact and physical separation of the actual development pods from adjacent properties. He added that noise standards were contained in the proposed zoning ordinance under industrial performance standards which would deal with this specific type of use.

The second item related to physical separation from adjoining properties. Concerns were raised at the prior hearing about the distance of the development pods to adjoining properties. Staff recommended that an additional buffer along the southeast property boundary be provided. This property line is impacted by a 20-foot wide sewage easement which provides some distance but no effective buffering from adjoining residential properties. To address this issue, staff felt that the required 50-foot PUD boundary buffer should be increased to 75 feet or the equivalent of the "E" Bufferyard required for PD-IP abutting residential properties (from the proposed Zoning Ordinance). Mr. Meinert urged that staff would recommend approval of this proposed rezoning application with this imposed restriction that would provide an additional boundary buffer around the PUD. Additional testimony was provided regarding the applicant's flexibility under the new zoning ordinance in meeting the standards for the "E" Bufferyards through various options, i.e. increased setback and fewer plantings vs. berm/wall, denser planting with smaller setback.

Following brief discussion of the Board, Commissioner Thompson moved, seconded by Commissioner Lancaster, and unanimously passed, that the Board instruct the County Attorney to prepare the appropriate resolution approving this rezoning application with the recommended conditions of the Planning Commission and those of staff relative to the inclusion of the "E" Bufferyard requirement.

DISCUSSION ITEMS

Discussion - Treatment of cases which have been filed but not reviewed by the Board of Appeals because of the new Zoning Ordinance.

Mr. Meinert explained that the Commissioners adopting resolution did not include specific language relative to conditional use or variance applications "in process" under which the Board of Appeals had jurisdiction. He asked that the Commissioners provide clarification of the resolution that adopted the Zoning Ordinance so that applications filed prior to the date of the resolution can be processed under the zoning regulations in effect at the time the applications were filed.

A draft resolution offering clarification, provided by the County Attorney, Joseph Densford, was distributed to each of the Commissioners for review. Mr. Meinert noted that said document would provide that any application which was made for conditional use or variance before the Board of Appeal, filed prior to the Commissioners' action on the resolution prior to July 10, 1990, would be grandfathered in. At this point Mr. Densford provided additional information regarding legal implications of the draft resolution.

Commissioner Loffler suggested that the Board be provided one week to review the document, and the members concurred. The matter will be reschedule for further discussion next week (August 7, 1990).

Signatory Approval of Zoning Maps

Mr. Meinert provided the cover sheet from the official zoning maps for the President's signature, noting that Section 20.03 of the St. Mary's County Zoning Ordinance required that the official zoning maps be identified by the signature of the President of the Board of County Commissioners and must contain the County Seal and date of approval. Commissioner Loffler affixed his signature accordingly.
