The referenced individuals appeared before the Commissioners to present and review the *Operational Review* of the St. Mary's Nursing Center. At the request of the Commissioners, DHS conducted a comprehensive report on the current status of the nursing center and took into consideration some of the issues and operations of the past. The report included a Summary of areas reviewed; General Operations (Relationship to St. Mary's County, Administration,

Admissions; Dietary, Housekeeping/Laundry, Plant Operation and Maintenance); Clinical Services; Fiscal Services; General Issues and Concerns; 1993 Cox, Long, Askey Report; Employee Status Questions; Resident/Family Satisfaction Survey; and recommendations to improve the financial position of the center, which will require the cooperation of the County (although they pointed out that the facility is doing well financially).

During review of the report, representatives of DHS indicated that the nursing center was an above-average facility and one of which the citizens of the County can be proud. The principle weaknesses are the need to improve in the areas of restraints and skin care and reporting of fiscal information, and the major strength is the willingness of administration and nursing to improve the operation of the center.

The County Administrator advised that Hospice of St. Mary's was seeking to enter into an agreement with the Nursing Center which would allow Hospice to charge Medicaid/Medicare for certain individuals at the Nursing Center who are enrolled in a hospice program. Mr. Kachmar requested authorization to have the Nursing Center Administrator sign the Agreement between the Center and Hospice.

Commissioner Eagan moved, seconded by Commissioner Brugman, to authorize County Administrator Kachmar to allow the Nursing Center Administrator sign the Agreement as presented. Motion carried.

COUNTY COMMISSIONERS' TIME

Nursing Center Administrator Position

Commissioner Thompson inquired as to the status of the replacement for Jeffrey Lloyd, current Administrator of the St. Mary's Nursing Center. County Administrator Kachmar advised that there have been three licensed applicants to date; however, the position is being readvertised. If the position is not filled prior to Mr. Lloyd's departure, the County will have to buy the nursing home license for 30 days. He further advised that the current contract with the Building Authority and that this should be changed before the replacement is hired.

Environmental Education Classrooms

Commissioner Chesser referred to a letter from DNR (Fisheries Service at the Educational Outreach Program at the Piney Point Aquaculture Center) regarding the need for classrooms at the facility. DNR will pay for half and is asking if the County will pay the other half for the environmental education classrooms. 1,500 middle school students attended the classes in the past year and more are expected in the coming year. He stated he will get additional information and bring it back up to the Board for consideration.

Reef Program

Commissioner Jarboe advised that DNR is interested in bringing back the reef program that had been phased out by the State. DNR is looking for support from the Maryland Saltwater Fishermen and other organizations in cooperation with the watermen for the placement of an oyster bottom and plant reefs above the dive line particularly in the Patuxent River. This would create an oyster spawning area in the Patuxent. DNR is not requesting money, but is looking for support from the Commissioners.

Annual Report

Commissioner Thompson advised that the Public Information Officer was looking for input from the Commissioners for the Annual Report. She suggested that the Commissioners review the goals and objectives and highlight those that have been met.

EXECUTIVE SESSION PERSONNEL

DEPARTMENTS OF RECREATION AND PARKS/PUBLIC WORKS DERELICT BOAT PROGRAM

As a follow up to a previous presentation by the Department of Natural Resources, Mr. Rollins appeared before the Board to present staff's recommendations relative to the State's Derelict Boat Removal Program. He stated it was Recreation and Parks and the Department of Public Work's recommendation that St. Mary's County participate at the "Partial Participation" level. At this level the State would identify abandoned vessels and debris; determine if the vessel is abandoned per the law; send all notices as per the law; and provide standard funding to the County for this purpose. The County would remove or contract for the removal of abandoned vessels/debris using State funds. Mr. Rollins pointed out that the Parks Division of Recreation and Parks will handle the County's responsibilities regarding this function.

After discussion Commissioner Jarboe moved, seconded by Commissioner Chesser, to authorize Commissioner Thompson to sign the Abandoned Boat and Debris Removal Participation form (at the Partial Participation Level). Motion carried.
