MAIL LOG ISSUES ANONYMOUS LETTERS AND COMPLAINTS

Commissioner Jarboe questioned the placement of anonymous letters on the mail log stating that he puts them in the trash can stating that he did not believe that they should get recognition by being placed on the mail log.

In addition Commissioner Jarboe raised the issue of anonymous complaints received at the Office of Planning and Zoning. He suggested that the Department of Planning and Zoning develop a policy to require the complainant to sign a registered complaint so that the individual being complained about could face his/her accuser.

After discussion Commissioner Jarboe moved, seconded by Commissioner Brugman, that the Department of Planning and Zoning establish a policy to register complaints and that it be public information.

Commissioner Brugman moved, seconded by Commissioner Jarboe to clarify the motion that the complaint be made public to the person who the complaint was against. Motion carried three to two with Commissioners Thompson and Chesser voting against.

Vote on the main motion was three to two with Commissioners Thompson and Chesser voting against.

The Department of Planning and Zoning was directed to draft the policy and submit it to the Commissioners for consideration.

ALCOHOL BEVERAGE BOARD ALCOHOL ENFORCEMENT COORDINATOR POSITION

As a follow up to last week's discussion, County Administrator Kachmar advised that the Sheriff, Alcohol Beverage Board and the Finance Director met to discuss a resolution to the issue regarding the Alcohol Enforcement Coordinator position. It was recommended that for FY 1999 the Commissioners place funds in the ABB budget for a Sheriff's deputy to perform the enforcement services for the ABB, and that an internal fund transfer be used to pay for the services of this deputy. It was further recommended that the Sheriff be given an additional deputy position, but with no additional funding. The Sheriff will be able to fund the position through funds available as a result of personnel turnovers and delayed hirings.

Areas of discussion included providing enforcement coverage for balance of FY '98 (including the need for enforcement on the weekends); future years funding sources; and selection process for the enforcement coordinator position, which will take about three or four weeks).

After discussion Commissioner Jarboe moved, seconded by Commissioner Brugman, to use up to \$5,000 from the Reserve Account to allow the Alcohol Beverage Board to contract for a plainclothes officer to serve as enforcement coordinator for the weekends until the Fiscal Year 1999 budget takes effect. Motion carried.

The County Administrator indicated he would present the appropriate paperwork to implement the Commissioners' decision and stated that the inclusion of funds in the FY '99 budget will occur during the finalization of the budget on May 26.

COUNTY COMMISSIONERS' TIME

Flower Day Memorial

Commissioner Jarboe advised the Commissioners that there will be a *Flower Day* on Saturday, May 2 at the Courthouse in Leonardtown, in memory of Frank Klear who recently passed away. Flowers will be provided by the State's Attorney's Office and the Community Services Program.

County Administrator's Contract

Commissioner Eagan advised that the Commissioners had voted for Commissioner Thompson to sign the County Administrator's contract, and that it was her understanding that it has not yet been signed. She stated that she would like for it to be brought before the Board so that it can be signed.

Commissioner Thompson stated that she had not yet signed the contract because it included a step increase and she questioned whether he was eligible for one at this time. She referred to the motion approving the contract which indicated a one-year contract with any merit increase that he was entitled to; however, because he was a step 9, and the Personnel Manual states that after Step 6, increments are given every two years after a satisfactory evaluation. She pointed out that Mr. Kachmar was given a raise last year and that she did not believe he was entitled to one this year.

Commissioner Eagan questioned why the contract was not signed after direction was given by the majority of the Board. She stated that if the President had a question of eligibility that it was important for the President to inform the Commissioners she had these concerns which the President did not share with three board members.

Commissioner Brugman moved, seconded by Commissioner Eagan, to authorize the vicepresident to sign the County Administrator's contract. Motion failed two to two to one with Commissioners Thompson and Chesser voting against and Commissioner Eagan abstaining pending comments from the Director of Human Resources regarding this issue.

Later in the discussion Mr. McClintock, the Director of Human Resources advised that in June of 1997 Mr. Kachmar was given a "pay adjustment" not a merit increase and therefore, was eligible for a merit increase this year

After some discussion Commissioner Thompson signed the Contract as presented.

Nursing Center Administrator's Contract

The Board of County Commissioners was made aware Mrs. Thompson had not signed Mrs. Newman's contract as she was directed.

Commissioner Thompson stated that the contract for the Nursing Center Administrator indicates that the individual is a county exempt contract employee, and that it provides for a flat salary rather than using the County's pay scale. She stated that she believed it should be on the county's salary scale and that upon completion of a satisfactory evaluation, she would be entitled to a merit increase.

After discussion the Commissioners agreed to leave the contract as is with the understanding that if there were any changes in the administrative operations of the nursing center, the contract could be amended accordingly.
