Commissioner Eagan moved, seconded by Commissioner Chesser, to authorize payment of bills. Motion carried.

Commissioner Eagan amended the main motion to approve and sign Ordinance 98-35 and to authorize Commissioner Thompson to sign the accompanying Budget Amendments as presented. Commissioner Thompson requested that funding for the IDEA positions be changed from federal grant funded to county funded, noting that the Board of Education requested additional funds for these positions which was granted by the Commissioners.

7. Department of Public Works
Pavement Overlay and Mowing Program

In response to previous inquiries by the Commissioner Eagan, Mr. Kachmar discussed a Memorandum dated June 15, 1998 as provided by George Erichsen, Director of Public Works, outlining the Pavement Overlay Program. Existing pavement conditions are rated annually by the department with respect to severity and extent of cracks, skid resistance, poor drainage, ride quality and traffic volume. The most effective overlay program or combination of programs is then selected based on need, priority and availability of funds.

Mr. Kachmar indicated that the Commissioners have received a petition from residents of Esperanza Farms requested that their roads not receive the maintenance treatment of slurry seal. Although the treatment leaves a residue (sandy grit) that remains loose on the finished surface, it dissipates in a short period of time; the loose gravel is sweep and/or vacuumed after the overlay has cured. Written notice is provided to residents which advises of the date of scheduled application and provides advice on how to travel on these roads immediately after treatment. The Commissioners expressed concern over the deterioration of the roads in Esperanza Farms should they not be maintained, but gave consent to defer the overlayment. They requested that a letter be sent to the petitioners explaining the consequences of this action on the subsurface of these roads and that the Public Information Officer and the Director of Public Works develop a public information program on the county's overlayment program for televising.

Concerning the county's mowing program, Mr. Kachmar advised that the 6,000 miles of county-maintained right-of-ways are mowed four times a year during the May1 through November 1 season.

PUBLIC HEARING

ALDP #98-0968 - JAMES SPENCE

48.43 ACRES, 75th Election District, Tax Map 38, Block 4, Parcels 6 and 271

(Requesting County Commissioners' approval on proposed Agricultural Land Preservation District (ALPD) establishment and sale of Development Rights Easement.)

Present: Donna Sasscer, Agriculture and Seafood Dev. Specialist, DECD

Ms. Sasscer read into the record the public hearing notice published in *The Enterprise* on June 3 and June 10, 1998, and advised that the property was posted and all contiguous property owners were notified. The application was approved by the Agricultural Land Preservation Advisory Board on February 4, 1998 and Planning Commission on April 27, 1998. Commissioner Thompson opened the floor for comments. Robert Lewis stated that the Planning Commission hosted a presentation on agriculture preservation and urged the Commissioners to watch the videotape. There being no other comments, the hearing was closed; the record will remain open for ten days for written comment after which the Commissioners will take action.

COUNTY COMMISSIONERS' TIME

State Highway Administration Issues

Commissioner Jarboe requested that the Board draft a letter to the State Highway Administration requesting the marking of the middle median turning lane on Route 5 in Charlotte Hall adjacent to the Farmers Market and establishing a reduced speed zone through the area.

Commissioner Jarboe inquired of Mr. Johnson, present in the audience, about the status of his efforts in getting a sign on Route 5 to direct traffic going to St. Mary's City to use Route 5 through Leonardtown in lieu of Route 235. Mr. Johnson indicated that, through the efforts of Senator Dyson, the existing sign was painted over and reworded to accomplish that about 3 or 4 months ago.

MACo Training Program / Circuit Court Staffing

Commissioner Chesser provided information from the the MACo Board of Directors conference in Aberdeen which he attended. One of the topics discussed was Circuit Court jurisdiction and obtaining financial help for staffing. Due to the large turn-over in local government, a training program entitled "Academy for Excellence in Local Government" is being developed by MACo in cooperation with the Institute for Governmental Service, Local Government Insurance Trust, and the Maryland Municipal League. This will be a two-year program, with four electives, with a certificate issued by the Maryland University. Some of the courses will be available at MACo's conferences for a fee of \$50.

Planning and Zoning Complaint Policy

Commissioner Brugman reported that he has received a complaint from a citizen who has been reported to Planning and Zoning for non-compliance and that the department refused to reveal the name of the complainant to him. Commissioner Brugman asked that the Board encourage the department to start following their 3-2 vote to reveal the complainant's name. Commissioner Thompson indicated that the department must follow current policy until the Commissioners' formally accept the revised policy, which has not as yet been presented.

Charles County Community College Tuition Refund Policy

Commissioner Brugman received a call from a family whose daughter withdrew from college due to the death of her brother. The college will not refund her tuition nor credit the account stating that it is against their policy and that the policy is typical of other institutions. He researched the issue and found that other colleges do indeed have bereavement policies. Commissioner Brugman asked that the Board send a letter to the Community College requesting the establishment of such a policy.

MACo Legislative Committee / Nuclear Regulatory Commission

Commissioner Thompson reported that the Legislative Committee is requesting input for next year's legislative packet. Also the Nuclear Regulatory Commission is applying for a 20-year extension for the Calvert Cliffs. The approval process will take approximately 2 years with a series of meetings and public hearings. The Commissioners have received information on meeting dates in their mail-log packets.
