Mr. Helwig explained the reason for the rate increase from \$2.50 a day (as previously requested) to \$3.50 a day, stating the changes in the prospective payment system that took effect July 1, 1998.

After discussion Commissioner Eagan moved, seconded by Commissioner Thompson, to approve the new room rates as requested. Motion carried 3-1-1 with Commissioner Jarboe voting against and Commissioner Brugman abstaining.

b. Personnel/Purchasing Issue - Reimbursement Policy

County Administrator Kachmar advised that the human resources position and the purchasing position have been added at the Nursing Center, and will be under a interlocal government contract between the Nursing Center and St. Mary's County Government. The purchasing position will also be doing work for the County, which will be paid for by the County.

- 4. Department of Public Works
 - Modification to Existing Solid Waste Refuse Disposal Permit to include Secondary Scrap tire Collection Operations at St. Andrews Landfill.

Mr. Erichsen explained the purpose of the permit modification stating that there are a number of permits required relative to solid waste, including tire disposal. The State is trying to consolidate these permits and streamline the process.

Commissioner Jarboe moved, seconded by Commissioner Eagan, to approve and authorize Commissioner Thompson to sign the Modification as presented. Motion carried.

b. Deed dated September 29, 1998 between Florida Rock Properties, Inc. and Board of County Commissioners of St. Mary's County granting to the County three acres for the purpose of realigning Breton Beach Road, Third Election District.

PUBLIC HEARING AMENDMENTS TO ETHICS ORDINANCE (FINANCIAL DISCLOSURE REQUIREMENT)

The Commissioners conducted a public hearing on amendments to the St. Mary's County Ethics Ordinance relative to Financial Disclosure Requirements.

Proposed changes included:

- Requirement for appointees to file a Financial Disclosure Statement if position is required to do so;
- To add the following to the list required to file FDS's: Board of Education (as requested by the Board of Education); Alcoholic Beverage Board; Agricultural Preservation Board; Historic Preservation Board; Director of Capital Projects; and ad hoc committees providing advice and/or recommendations regarding acquisition, zoning, or designation of land, whether appointed by the Board of County Commissioners or appointed by other local government boards or commissions authorized to make such appointments.
- To eliminate the Chief, Inspection and Enforcement and the Plumbing Inspector.

Commissioner Eagan indicated the Commissioners received a telephone call expressing opposition to adding the Agricultural Preservation Board, and she inquired as to why this Board was added. Mr. Baggett responded that it was added because it advised on the designation of land.

Commissioner Brugman inquired as to those individuals who would now be required to file under this new provision. Mr. Baggett responded that they would be given 30 days from adoption of the Ordinance to do so.

Hearing no comments from the audience the public hearing was closed.

DEPARTMENT OF PLANNINGAND ZONING CASE NO. SPEC 98-2335 – HEPP ENTERPRISES, INC. (REQUEST FOR ESTABLISHMENT OF PHOTOGRAPHY STUDIO/LAB IN I-1 ZONING DISTRICT)

DISCUSSION / DECISION SPEC #98-2335 - HEPP ENTERPRISES, INC.

Requesting approval of *photographic studio/lab* as a permissible use in the I-1 zoning district, in accordance with Section 10.8.4 of the Zoning Ordinance.

The property contains 1.52 acres and is located on MD 5 at Gregory Lane, outside Leonardtown corporate limits. TM40, Blk6, Parcel 57.

Applicant/Present: Noel Hepp

On August 31, 1998 this applicant filed a request for zoning authorization to establish a photography studio and lab within the I-1 zoning district. The application was denied by staff, as Table 2.6 of the Zoning Ordinance does not allow such uses within the Industrial zone. Applicant proposes a photographic business that entails business office operations and the use of photographic equipment to produce photographic and video products, and office visits by clients. He stresses that this will be more than a portrait-type studio.

On October 26, 1998, the Planning Commission conducted a public hearing, found no appreciable difference in the quality, character or degree of the proposed use compared with other such uses as contained in *Table 2.3* of the Ordinance, and declared photographic studio/lab to be a permissible use in the I-1 zoning district, in accordance with Section 10.8.4 of the Ordinance. The Commission's declaration must now be sanctioned by the County Commissioners.

In response to Commissioner Chesser's inquiry, Mr. Hepp stated he will do some portraits for weddings and some commercial art work. He will be using industrial photographic equipment and eventually will go into producing and editing videos, making TV commercials off-site and on-site.

Commissioner Jarboe agreed with the Planning Commission Chairman's statement that the Industrial zone should be the least restrictive of all zoning districts and asked if this "quirk" can be addressed in the upcoming Ordinance update.

Mr. Lackie replied there might be some uses that would not be conducive to the I-1 zone, for instance because of truck traffic, noise, etc. However, he added that we will be looking at defining "use groups" in the Ordinance update which we could apply some of this type of "new businesses" to.

Commissioner Brugman moved that the use of photographic studio/lab be approved as a permissible use in the I-1 zoning district, in accordance with Section 10.8.4 of the Zoning Ordinance. Seconded by Commissioner Jarboe and passed by a vote of 5-0.

ORDINANCE NO. 98-46 HOMESTEAD TAX CREDIT PERCENTAGE (DISCUSSION/DECISION)
