#### SOUTHERN MARYLAND CHILD CARE RESOURCE CENTER

The referenced individuals appeared before the Board to provide a briefing on the purpose of the Resource Center, and its services to the tri-county area. The Center, which has been in full operation since December, provides parents with referral services and assistance in locating child care; provides training, technical assistance, and behavior management consulting to child care providers; and maintains a resource library with a wide variety of child care and child development related materials.

Areas of discussion included initial State grant in the amount of \$232,235 with a two-year renewal; significant increases in the number of referral requests (from 25 in December to 240 in March); costs for establishing a child care facility; licensing requirements; child care providers for children with physical disabilities; and the need for more infant care facilities in the area.

# OFFICE ON AGING MEDICAL ADULT DAY CARE SERVICES

Mr. Carter and Ms. Knott appeared before the Board to present and review the Grant Application Renewal for the St. Mary's County Medical Adult Day Care Services for Fiscal Year 2000. The application, to be submitted to the Department of Health and Mental Hygiene, is in the amount of \$83,591; (\$22,971 is the local match from the County.) The Program provides medical day care for individuals in danger of institutionalization, and he/she must meet income and health criteria.
