1. Call to Order at 8:31 a.m.

- 2. Pledge of Allegiance, Moment of Silence observed
- 3. Since we have five new members, everyone took a few minutes to introduce themselves and explain their interest in being on the board.
- 4. Roll Call: D. Sprinter verified presence of a quorum
- 5. Approval of minutes: no comments were made on the minutes, Brian Barthelme moved to approve, Victor Govier seconded, and the motion passed unanimously

6. Old Business:

- Dale Springer extended a thanks to everyone for stepping up to serve, and expressed pleasure at people having so much experience with the county and its history, looking forward getting lots done this year.
- Election of officers: Brian Barthelme moved that the slate designated last month be accepted, Victor seconded, and the slate passed unanimously.
- Karen Stone gave an orientation to the Board, with help from Arthur Shepherd. Topics covered included the following: the organization of the Parks and Recreation Division; our position as an advisory board with a responsibility to provide guidance; the Division's Budget; the Division's Subunits, including what the Parks and Recreation Divisions do; the Land Preservation, Parks, and Recreation Plan, which is updated every five years and is necessary to get state funding; the different museum locations, including Piney Point Lighthouse and Museum (with April Havens giving a detailed update of activities there), St Clements Island and Charlotte Hall Schoolhouse, the U-1105 "Black Panther," and Drayden African American Schoolhouse; staffing of the museums; the relation between the museums, the Friends of the Museum, and the Museum Board of Trustees; the St Clements Hundred's oversight of the Blackstone Island Lighthouse; relationship to Maryland Department of Natural Resources; Museum alliances in the community, including UCAC, MD Historic Trust, Maryland Heritage Area, and 7th District Optimists; various current projects at the museums, including trails, new signage, UV film on windows at SCIM, accreditation process from American Alliance of Museums; upcoming special events.
- Arther Shepherd talked about the Trustees role in advising in negotiating a lease for use
 of St Clements Island with various stakeholders, including Department of Natural
 Resources and St Clements Hundred.

- D. Springer updated the Trustees on the remodeling of St. Clements Island Museum and how the Trustees will be a part of this discussion in the future. Karen gave an update on the plans for this renovation, including the capital funding for it. This led to a more general discussion of the Museum Division in the County CIP.
- The American Alliance of Museum (AAM) re-accreditation process and application were reviewed. We are developing a Master Plan for Museum strategy as part of this process. We expect re-accreditation in June for 10 years, making us one of about 16 museums in MD with this prestigious accreditation (allowing us more visibility, greater ability to borrow historic items from other etc).
