- 2022 Renewals for approval
 - 1 As stated in Section 2.11(g)(2) of the Rules and Regulations of the Alcohol Beverage Board of St. Mary's County, no hearing shall be required for a renewal unless the Board Administrator has reason to believe that discretionary action by the Board is necessary:
 - Patuxent Fine Wine & Spirits – Per Section 4-205 of the Maryland Alcoholic Beverages Article of the Annotated Code of Maryland, a local licensing board may not issue a Class A, Class B, or Class D beer license, beer and wine license or beer, wine, and liquor license for use in conjunction with or on the premises of: (1) a chain store; (2) a supermarket; or (3) a discount house.
