Chairman Report:

- Youth in Aviation SOMD two successful meetings with participants from Great Mills High School. Thanks to LCDR Steve Palmer, CDR Jeremy DeBons, and George Hill for setup and coordination of meetings and presentations on 12/4/21.
- Farmer's Market on 12/18 9am 1pm. Santa Fly in approximately 1130.
- Retirement Social for John Deatrick will be 12/21 from 1400 to 1530. All Board members invited. His retirement date is 12/31. Tonight is last meeting with AAB.
- AAB officer elections at January meeting. Anyone interested in Chair, Vice, or Secretary please let Allison Swint know.

DPWT Report (Swint, Airport Manager):

- Construction doing well. Displaced threshold opened with no difficulties 11/30.
- Plan to move aircraft on tie-downs on West Ramp temporarily to East Ramp.
- Plan to complete terminal construction efforts by end of January.
- Introduced David Gately, new employee for DPWT and airport manager.
- Discussion of FAA requirement to perform annual inventory of aircraft located at the airport. Primary emphasis is on accurate reporting and the larger the number, the better the opportunity for grant funding.

Deatrick (DPWT):

- Appraisal completed on property that is available on North side of runway.

FBO Report (Weaver):

- Doing annual door/fire/lights inspection required for hangars.

Pax Air Ops Report (LCDR Palmer): Absent.

Old Business:

- Meeting minutes and action Item list from 10/25/2021 approved unanimously (motion Lightstone/second Hill).



- Proposed Chart Supplement update approved unanimously (motion Lightstone/ second Hill). Added wording improves traffic deconfliction between Pax River and 2W6.
- Proposed SOP updates reviewed and approved (motion Lightstone/second Hill).
 Only voted on Red Line changes presented in document. Primary issues were:
 - Wash Rack Area and Self-Maintenance Area
 - Gate FOB policy
 - Update regarding reporting of accidents/incidents
 - Update on pilot lounge/flight planning area which should be open in January 2022
 - Consistency of verbiage in changes regarding wash rack, maintenance spot, and other minor necessary changes

Ken Reed brought up items originally addressed at last meeting. These items did not make it into the final document provided by Allison Swint and thus still couldn't be voted on. There was a short discussion of appropriate process and why it should be changed at a later update.
