### 3. NEW BUSINESS

A. Presentation from Visit St. Mary's MD: Liz Mildenstein, Director

- Visit St. Mary's MD is a non-profit that exists to promote tourism in the county, especially overnight visitors and day-trippers, and helps its many partners ensure that tourist visits are enjoyable.
- The county had over 826,000 visits, generating \$46.8 million in hotel tax revenue, with annual spending of \$221 million.
- Partners include state and county government, lodging providers, museums and historic entities, and business. It is a membership-based nonprofit, but there are no fees for membership.
- New initiatives include a Marketing & Sponsorship program that will begin in January of 2025. Eligible entities can apply to have public events advertised.
- The Tourism Ambassador Program will promote an improved visitor experience by sharing knowledge of the many things to do in the county.

A. St. Mary's County Museum Division 2025 Budget

- It is still in process. There are no new Construction in Progress requests. There is a request to make the boat captain fulltime.
- The new boat was intended to be fiberglass, but the only eligible maker for a boat of this size/type was destroyed in a Florida hurricane. The boat will now be aluminum, with some cost savings.
- There are some minor changes (extra marketing money), but the budget is nearly ready and will be submitted to the Commissioners.
