 - The Budget has been submitted to the county; it does include extra hours for boat captain/mate and for marketing money
 - The division wants to put in free-standing (not connected to the Intranet) kiosks at Piney Point, with videos on the Fresnel Lens, the sunken U-Boat, and various lighthouse keepers. This item has been picked up by the IT department for their budget.
 - The department's new marketing position has been hired
 - Museum Board members are asked to keep track of their volunteer hours, either keeping a list until December or submitting on a case-by-case basis to Karen and Andrew.
 - Questions about the museum capital presentation:
 - Where will the mural be located? Close to the entrance of the museum itself, along a long wall
 - Will there be a key to identify people in it? Yes, a key will be on hand to identify people and also some things the mural may not have exactly correct
 - Why have the captain year-round? The new boat will be more enclosed, so the season can be extended; the captain can do necessary maintenance during the three-month off season
 - Will the existing dock need to be expanded? No, the dock will work and the boat il have a temporary ramp to make it ADA compliant; the docks on the island are being re-done by the state.
 - Will the docks on the island be done in time for the new boat? Yes, and all completed as one large project
