Whereas, the County Commissioners of St. Mary's County, Maryland, has certain funds to its credit impounded in the First National Bank of St. Mary's, at Leonardtown, Maryland, for the express purpose of redemption and payment of certain authorized obligations of said county, which said fund is not immediately available.

And whereas, the County Commissioners of St. Mary's County, Maryland, in its discretion deem it necessary to provide money for the payment of the aforesaid authorized obligations.

Now therefore be it resolved, "That the County Commissioners of St. Mary's County, Maryland, borrow from the Leonardtown Bank of the Eastern Shore Trust Company, Leonardtown, Maryland, the sum of Thirty-Two Hundred Dollars (\$3200.00) upon the faith and credit of said county, on its note, payable on or before six months after date, with interest at the rate of six per centum per annum. Under authority vested by Chapter 154 of the Public General Laws of Maryland at the Session of 1933.
