Petition of Parents Teachers Association, of Great Mill High School, asking for additional room for that school, read and action action on same deferred spring of 1935.

Dr. T. B. Symons of Maryland Extension Service, by appointment with the Board, discussed the appointment of a County Agent for St. Mary's County. Dr Symons appointed Mr. Julius Johnson, County Agent for St. Mary's County, on probation for one year, effective Jan. 1st. 1935.

A motion by Mr. Bailey, and seconded by Mr Bradburn, that the County Commissioners accept the appointment of Mr. Johnson, unanimously carried. Mr. Johnson notified of his appointment.

The Board agreed to appropriate a sum of money, at the rate of \$900.00 per year, for Extension Work.

The clerk was instructed by the Board to write the Catholic Clergy in charge of Parochial Schools in St. Mary's County, to meet the Board at 10.A.M. Jan. 3rd. 1935, at the office of the County Commissioners, Leonardtown, Md, in order to enter into an agreement with the Catholic Clergymen in the matter of transportation of school children to and from Parochial Schools. *said*

Geo. E. Hamilton was appointed Custodian at a salary of \$200.00 per year, said appointment to be of same duration as his term as clerk.
