Leonard Redman, Hollywood, Md., & Jos. Goldsboro, Dynard, Md applied for assistance from U. P. A. funds. Board denied both requests.

Mrs. Jas. Waring, of Welfare Board, requested an increase of \$12.00 per month to provide for Aid to Dependent Blind, same to be used for the three blind cases formally granted a total of \$26.00 per month. Board granted this increase.

Mr. Howard Britton, of the W.P.A. reported 17 men on work relief would be laid off in a few days because of completion of a project near Mechanicsville. A new project can be started, but due to non-approval by Mr. Joe Chaney of the S.R.C. same could not be started. This was due to the fact that S.R.C. does not have trucks available for this new road project. Clerk was directed to write Mr. Chaney for an expression as to what can be done in this matter, ### or any other project whereon these men can be employed.

The terms of the appointment of the Attorney and Clerk to the Board of County Comm. having expired, the Board unanimously reappointed the present incumbents for a term of two years.
