Minutes last meeting read and adopted.

Miss Dent of the School Board, advised the Commissioners that a move was on foot for the equalization of the salaries of white & Colored teachers, and that a petition to that effect would probably be presented to the School Board in the near future.

Miss Dent related developments in Montgomery & Calvert Counties, where compromises had been effected.

Mr. Frank Bailey & others requested Board to continue the improvement of Parsons Mill Road or Robert Long Road, one mile further to Friendship School. Board agreed to do this and advised Mr. Webb to continue the work to Friendship School.

Richley Brown requested Board to take over as County Road, Section of Road from Glebe School to Forest Farm. 3rd. Dist.

Mr. J.A. Norris requested Board to take over as County Road, road from Horse Head to Great Mills, 3/4 mile, 8th Dist.

Mr. Jos F. Crew requested Board to take over as County Road, 300 yard extension of the White Neck State Road, 7th. Dist.

Mr. Webb requested to make a report on the the above 3 roads.

Mrs. J. B. Stallman, California, requested Board to give G.P.A to her Sister, Bertie Williams,. Held for futher information.

Rodie Barnes, Leonardtown requested G.P.A, also C. P. Speith of Leonardtown. No. aid rendered in these two cases.

Miss Harriette Reeder, and Mrs Burroughs, requested G.P.A. for Raymond Goldsborough, until the W.P.A. opened up. Board allowed 3.00 week in this case.

Board accepted Right of Way Deed from J. Frank Coppage et al for section of road leading from Valley Lee- Porto Bello State Road to Carthage Farm, 2nd Dist, for a distance of 6008.6 ft.

Clerk directed to write S.R.C. recommending that this road be accepted as part of County Road System for maintenance.
