Minutes of preceding meeting read and approved.

Mr. Chapman Thompson, County road engineer, requested the Board to select 3 more roads to be improved as W.P.A. projects. The Clerk was instructed to write Mr. Chaney District road engineer and recommend the following roads for improvement as W.P.A. projects. Bell Road, about 1.3 miles, 8th Dist.; Frogs Marsh road, about 1.45 miles 2nd Dist.; Trent hall road about 1 mile on the Mechanicsville end, 5th Dist.

Mr Jos. L. Davis, requested the improvement of the Chaptico-Thompson Corner road Claiming about 1 mile on the Thompson Corner end of this road is now impassable, total length of road about 2 miles, 4th & 5th Dist. Mr. Davis stated that the prospective sale and improvement of farms in the vicinity of this road would probably double the assessment of a number of farms if there was a good road there. Mr. Johnson agreed to make a personal inspection of this road.
