The Board instructed the Clerk to order the necessary equipment to enable

the Inspector of weights and measures to procede with his work.

Dr.F.A. Camalier, representing the "Lions Club"urged the Board to provide for a labratory at St. Mary's Hospital. Dr. Camalier stated that the Hospital would supply room for the labratory and that he thought that sufficient equipment could be purchased for \$400.00, and that the probable cost of maintenance per year would be \$75.00 for materials and \$900.per year for a Nurse qualified as a Technician and that the Hospital would bear one Half of the Nurse's salary, making the net cost of maintenance to the County about \$525.00 per year. No action taken.

The Board instructed the Clerk to ascertain from St.Mary's Hospital just what rule was applied in determining when a charity Patient was to be a direct County charged. When such a case was covered by the State appropriation for charity Patients.

It was stated that Mr. Roger Elliott would donate the gravel for building this road. Mr. Thompson asked to report and to contact Mr U.W. SMith.

Mr. John W. Hurry requested aid for Jack Young. Mr Hurry was advised that the Welfare board had allowed Young \$8.00 per month GPA. The Board agreed to provide the Welfare Board with \$2.50 extra each month to enable them to grant James Purcell \$5.00 per month Gpa until he is able to get O.AR. The Board granted the Welfare Board 1.50 for WM. Farrell and 1.50 for Joseph Goldsborough, as temporary GPA.

Peter Biscoe asked aid for Susie Long. He was referred to the Welfare Board.
