Minutes of preceding meeting read and approved.

C.B. Greenwell, Clerk of the Court, submitted prices for furniture he had asked the Board to provide for the room adjoining the Clerk's office. Mr. Greenwell was asked to take the matter up with the Comptroller and see if he would be allowed to use the surplus funds of his office to furnish the room, since it is, to all intent and purpose, a part of his office.

Mr. Thos. B. Clarke made an offer to the Board of \$25.00 for five tax sale lots adjoining his farm in the 1st Dist. Since the time for redemption of one of the lots has not expired Mr. Clarke was advised to take the matter up again late next January.

The Board decided that it would invite the St. Mary's members of the Legislature to discuss with it the special law now in force requiring the County Commissioners to levy \$1.50 per day for each charity patient in St. Mary's Hospital, regardless of the State appropriation for charity patients.

Capt. Mat. Trimble asked the Board to have Fish's Lane, about 1 mile, 8th Dist. Surfaced with gravel. Mr Thompson asked to report.

The Board decided to recommend to the S.R.C. the acceptance into the County road system of the Cryer road about .4 mile, 7th Dist.

The Clerk was instructed to write the S.R.C. that the W.P.A. workers in this County were about to run out of work, and to again urge the approval of the Baptist Church road as a W.P.A. project and also to recommend the approval of the State road from Loveville to the Three Notch road as a W.P.A. project.
