Minutes of preceding meeting read and approved.

The Board agreed to sell to Thos. B. Clarke, for \$25.00, the tax sale lots ~~of~~ formerly owned by Harriet A. Barnes, Hester Jones, Susan Smith, Elizabeth Curtis and Alex. W. Clayton, all in the 1st Dist. Mr. Clarke paid a deposit of \$5.00

Miss Lettie M. Dent, Super. of Schools, discussed with the Board the pending question of equalization of colored Teachers salaries. She stated that the Colored Teachers had agreed to accept an additional monthly payment for the ~~xxxx~~ current school year, in lieu of equalization for this year and that it would require \$2545.00 to do this. The Board agreed to levy this amount. Miss Dent estimated that it would cost the County about \$4130.00 for equalization <sup>1941-1942 school year</sup> if pending Legislation was passed.

Mr. Eddie Nelson requested the Board to accept into the County road system, for maintenance, road running from Leonardtown-Clements State road to "Horton Park", about 400 yds, 3rd Dist. Mr. Thompson asked to report and to contact Mr. Nelson.

Mr. Ell Trossback again requested the Board to accept into the County road system for maintenance, road from the St. Jeromes Neck ~~xxxx~~ County Road to his place, 1st Dist. He claimed that, Wm. Trossback, Lewis Trossback, Leo Trossback and James Bradburn would also be benefitted by the road. Mr. Thompson asked to report on this road again.

Clerk instructed to recommend to the S.R.C. that the Richley Brown road, 2nd Dist be accepted into the County road system for maintenance.
