Minutes of preceding meeting read and approved.

The Clerk called the Boards attention to the fact that the American flag was not flying from the Court House, and that the County had no flag and no flag pole. He was instructed by the Board to take the necessary steps to correct this situation and to see that a flag was kept flying from the Court House in future.

Mr. A. F. King, Director and Dr. Eugene C. Peck appeared before the Board in the interest of Civilian Defense. They explained the steps that had been taken to meet possible war emergencies in the County and Dr. Peck exhibited a sample of a combination Stretcher and Cot he had designed for emergency use and which he could with the aid of the Colored School Teachers have made at a very low ~~price~~ cost. The Board authorized him to have the necessary ones made and also authorized the purchase of 30 blankets for emergency use. Mr King asked the Board for \$15.00 for Stationery for the Directors office, and for \$60.00 to cover the expenses of the Air Raid Warden in establishing lookout stations in the County, and for \$48.00 for the purchase of Red Cross text books. The Clerk was instructed to make out checks for the above amounts and charge same to the G.P.A. account.
