per day.

The Attorney to the Board was instructed to take up with the proper authoris the question of compensation for County property, such as roads, Public Landing, and wharf in the section to be taken over by the U.S. Goverment.

The Board agreed to provide an increase of \$200.00 per year in the salary of the Extension Service Secretary, effective as of Jan, 1, 1942, to be paid monthly from the Com. Gen. Fund until the next levy is effective.

The Clerk was instructed to pay to the County Treasurer 825.00 for Attorney

fee, in connection with tax sale work.

The board agreed to provide funds to defray the expense of installing telephones in Spotter posts.

The Clerk was instructed to write the S.H.C. and again recommend the acceptance of the Peg road,8th Dist,into the County road system for maintenance Received from:
