Being a special meeting the minutes were not read.

In regard to the claim that about 2 acres of land owned by Mr. A. E. Stone, on the west side of St. Clements Bay, 7th Dist. should be condemned for public use because it had been used as a public landing for many years, Wm. A. Loker Atty. for Mr. & Mrs. A. E. Stone, claimed that this land had not been used as a public landing for the purpose of handling produce or freight for many years and that title to the land could not be acquired by public use; and that before condemnation proceedings were started it should be shown that it was a public necessity and not merely for the pleasure of the public. Mr. Loker further contended that if it was shown that this landing was necessary for the public need, then a survey should be made to determine whether Mr. Stone's site or some other location would better serve the public need. Mr. Stone stated that "Woodlanding" had not been used for freight purposes since the Spring of 1922 and that he had only fenced off the land in question about 3 weeks ago after some one had stolen his gate during his absence from home. Mr. Geo. L. Lawrence stated that he had hauled fertilizer from the landing as late as 1928. Mr. Stone apologized for his first statement but still thought that the fertilizer was hauled not later than 1923, and he said that he would not undertake to prevent any one from making proper use of the landing at any time. No action taken by the Board. *Board proceeded with work on new survey*
