Minutes of preceding meeting read and approved:

Board fixed the salary of T.B. Brookbank, J.P. at \$50.00 per year and instructed the Clerk to pay the balance of \$30.00 ~~from~~ for the fiscal year 1942 from the Com. Gen. Fund, only \$20.00 having been levied for his salary.

Wm. Alec. Loker, Atty. for the Commissioners of Leonardtown, appeared before the Board and claimed that the Corporation of Leonardtown had not been sharing with the County in the Financial Institution Shares tax, as it was entitled to do under the law. Mr Loker claimed that the County owed the Town its share of this tax from the year of 1939 on. The Clerk was instructed to ascertain exactly what amount, if any, was due the Town for each year, by the next meeting date, when the matter would be given further consideration.

On the certificates of Dr. R.V. Palmer and Dr. Frank A. Camalier the Board committed Dawkins Jones to Crownsville State Hospital as of June, 17, 1942.

And on the certificates of Dr. Robert T. Fuchs and Dr. P.F.J. Bean the Board committed Matilda Clapsis to Spring Grove State Hospital as of July, 3, 1942.

The Clerk was instructed to write the Greyhound Bus Lines and ask that their scedule be ~~changed~~ to have the bus leave Leonardtown around 8.00 A.M. instead of 10.45 A.M in order to give people more time to attend to business in Baltimore or Washington .

Mr. C.S. Meyer and Mr Abell asked that the County road from the Compton State road to Mr. Sears Gate be Straightened and ~~repaired~~ improved about 1 mile, 3rd Dist. Mr. Thompson asked to report.

Mr Thompson also asked to report on the advisability of accepting into the County road system, for maintenance, road at Patuxent Beach running west from the Hotel, about .25 mile, 8th District, and to contact Mr. Archie L. Peterson.
