Minutes of preceding meeting read and approved.

Miss L.M. Dent, Superintendent of Schools and Mr. Paul J. Bailey, Attorney to the Board of Education appeared before the Board and again urged that the County provide the money to enable the Board of Education to purchase land for the enlargement of the Great Mills High School grounds. The Commissioners decided that in as much as the F.W.A. had made provision for the purchase of this land if and when they build the new High School, they would not provide any funds for this purpose.

Miss Dent and Mr Bailey also asked the board to provide funds to pay each teacher a bonus of \$20.00 during the months of May and June 1943, and enough additional to make \$140.00 per teacher by January, 1, 1945, of which the State would refund to the County \$27.00 per Teacher. After much consideration the Board decided that it would make some provision for the Teachers in the next levy, but did not fix the amount.

The Board Authorized Commissioner Jarboe to contact Mr. Jas. J. Baldwin, Architect and find out just when it is proposed to start work on the Great Mills High School, and if Mr. Baldwin can not supply the necessary information Mr. Jarboe to arrange with Mr Baldwin and Mr. Paul J. Bailey or Wm. Alec. Loker to go with him to Richmond, Va. and endeavor to find out from the F.W.A. just what was holding up the work on this project, and when we might expect the construction to start.

The Board Committed John Curtis to the Alms House, as of this date.

The Board fixed the salary of Geo. L. Lawrence, Supervisor of Assessments at \$1500.00 per year, effective from June, 1, 1943, as provided in the State law of 1943; and instructed the Clerk to pay the difference between this amount and the amount provided in the levy from the Commissioners General Fund.
