Minutes of preceding meeting read and approved.

Miss Lettie M. Dent, Superintendent of Schools, appeared before the Board and made inquiry about the Public schools share of taxes on certain corporations certified by State Tax Commission after our 1943 base had been closed; and also to ask for the amount due for May Teachers bonus. Miss Dent was told that as soon as the Treasurer had paid over all taxes due the schools, that he had been able to collect, the County Commissioners would pay the balance due on total base.

The Clerk was instructed to make out a check against the C.G.F. in favor of Board of Education for \$1,640.00 being the amount due for May bonus payment to 82 teachers @ \$20.00 per teacher.

A request was received from Dr. Love in charge of Hospital at Naval Air Station, Patuxent River, Md., asking the Board to commit Dorothy Searcy, a mental patient, to a State Hospital, and it was claimed the State of Florida would later accept the patient as its charge. The Board felt that this should be a Federal responsibility, the woman being the wife of a sailor, and instructed the Clerk not to commit her, until all means had been exhausted to have the matter handled through other channels.
