REGULAR MEETING January 14, 1947

Board met at 10:15 a.m. Present, Matt R. Bailey, Pres. J. Frank Raley Frank Bailey.

This being the first meeting since the Board was organized, the following business was transacted.

ROADS. 6th District

Delegation from the 6th District appeared before the Board and requested that the Parson's Mill Road be repaired. This is a road between the 3rd and 6th Districts. Messrs. Raley Wathen Carol Knight and Richard Quade comprised the delegation. The matter was discussed and the Board conferred with Mr. Thompson who said he would do what he could for the road. This matter had previously been discussed with a prior Board, but the war intervening no action was taken.

3st District #1

Mr. Edgar Jones appeared before the Board with a request that a road be constructed at a point he designated, but the costs appeared to the Board to be too great for the number of persons who could be served by his suggested road, and no action was taken.

1st District #2

Mr. S.R.Bauer and delegation appeared before the Board and requested that a road be incorporated into the road system. Thirty foot Right of Way was dedicated to the County for road at the time the National Slovenic Society started their settlement in that section. Mr. Thompson conferred on this and it was decided that the recommendation be made.

8th District #3

Delegation was heard on the Indian Bridge Road. Messrs. Parran Cecil, Frank Combs, Jack Bean, Ed Combs, Jas.T. Combs, et al. Mr. Thompson informed that no Oil Schedule had been arranged for 1947, but it was decided that repair to the road could be effected and this was promised. The road to be gravelled this year and oiled next year, or to be included in next year's oiling schedule. 9th District #4

Mr. John Brsicoe presented a perition from residents of St. George Island on road improvement for that section. Petition was filed. Mr. Thompson, resident engineer. Matter is pending.

On the certificates of Dr. Frank A. Camalier and Dr. F.F. Greenwell, Walter Dawkins Clements was committed to Spring Grove State Hospital.

On the certificates of Dr. Frank A. Camalier and Dr. F.F. Greenwell, William Hires was committed to Crownsville State Hospital.

Extension Parochial School bus requested.

Request for extension of Parochial School children was presented by Eliza Ruskin; Scanlon Herbert's Route; dist. 5 mi; total 20 mi per day; amt. involved \$4.00 additional per day - under advisement.

Jacob Lawrence asks extension of Earl Gatton's route, so as to take his 2 children to school; dist 3 mi; amt. involved 60¢ per day, under advisement.

Electrical Board. Planning & Zoning County Welfare

It was decided that Capt. Matt Bailey be the County's representative on the Electrical Board, Mr. J. Frank Raley on Planning & Zoning; Mr. Frank Bailey on Welfare Board.

SCHOOLS

Miss Dent, Supt of County Schools and the Board of Education, accompanied by Messrs. Worthington; Den Davidson; H.R.Pembroke; Mr. Gleiter, representing the P.T.A of the County, appeared before the Board and discussed a long term plan for schools in the county. Miss Dent indicated an amount, approximately one million dollars would be required for a long term program, and pointed out that St. Mary's County had never had a bond issue for schools and that the physical properties for school purposes were deplorable. She said she did not advocate a Bond Issue specifically, but did urge that the Commissioners obtain sufficient funds to permit the improvements she deems necessary for the County's schools. Miss Dent exhibited a map and graphic chart showing the location of present school buildings, and indicated approximate locations for consolidated schools, as well as replacements, because of inadequate facilities. She also informed the Board she will have complete details on this subject at an early date.
