- 9th Board heard a delegation from St.George's Island requesting improvement to the roads in that area. A petition signed by eighty residents was presented for consideration. Oral advocacy of re-sunfacing was advanced. The questions were discussed at length. Board decided to view the conditions on Wednesday, Feb. 5th, inst. and will meet on the Island with Mr. Thompson, resident engineer at noon.
- 3rd. Mrs. Alphonsus Guy appeared before the Board and urged that improvement be effected at the entrance of the road leading to her place. She stated that a bad condition had obtained there for a very long time and that she had been before previous boadeds on the question but with out releif being granted. The matter was held under advisement pending an answer to a letter from Mr. Thompson to Mr. Chenny.
- 8th. Mr. John P.Rue, appeared before the Board re "Brick House Road" Asks that this road be incorporated in the road system. for maintenance. There are 6 or 7 families on the road. Mr. Thompson will report on this.
- 1st. O'Day Road "approved.
- 5th. "Horse Landing Road" approved.
- 8th. "Esperanza Road" Messrs Cochran and O'Brein appeared before the Board and requested improvement on this road. Board will view the project on Wednesday, Feb. 5th, 1947 with Mr. Thompson.
