ROADS.

Mr. Dickey request widening and repair of Frog Marsh Road. There are eight families served by this road. Pending
The Board desires to request the St. Mary's Delegation at Annapolis to do all in its power to prevent the County Roads from from being taken out of the hands of the State Roads Commission for maintenance etc, but urge that all county roads be continued under the S.R.C as at present.

SCHOOLS.

Mesdames James Herbert and Maude Gardiner of the S.M.C. Board of Education and Miss L.M. Dent, Supt of Schools conferred with the Commissioners and urged the necessity of an enabling act in order that should it seem advisable to approve a building and repair program for school in the county that the Commissioners would be in a position to entertain proposals for that purpose.
The Board approved the suggestion to request the S.M.C Delegation at Annapolis secure an enabling Act authorizing the County to borrow not in excess of \$200,000, at an interest rate not to exceed 3 % for the purpose of providing funds for school building and repairs. It being understood that the authorization in nowise commits the Board to exercise the authority, but is for the purpose of empowering them, if in their discretion, it should appear to them a public necessity for the common good, to exercise the authority thus granted.

PARKING LOT.

The Board directed their attorney to prepare deed for the area adjacent to the Court House Grounds to be used for a Prking Lot-
The consideration to be \$2,000.00

LAND PLATS

The Board resolves to request the S.M.C. Delegation at Annapolis to secure the passage of an Act to require the preparation, approval and Recording of plats of all sub-divisions of land in this county.

LEGISLATION- The Board discussed pending legislation affecting the County and decided to visit Annapolis and there confer with the S.M. Delegation on these matters.
Note; Board spent the day at Annapolis and together with other delegations met with the representatives of the county and made known their views.
