REGULAR MEETING

Regular meeting held Tues. Sept. 23, 1947, present Capt. M.R. Bailey

Mr. R.H. Pembroke, pres. St. Mary's Civ. Assn. with delegation appeared to "protest the rights of citizens of this County to hold public meetings in the Court House." He presented a Resolution drawn up by the Association in this matter. Resolution attached to Sept. 12, 1947 minutes herein.

Bulkhead at St. Geo. Isl.

Delegation from St. Geo. Isl. appeared relative to road work requested at earlier date, under consideration by the Bd. Right fork of road recommended for widening and resurfacing this year; to be oiled and tarred next year. On instructions from Bd. Mr. J.H.T. Briscoe had prepared an agreement between the Bd. and Mr/ Stephen T. Foxwell relative to erecting bulkhead on island. Mr. Foxwell advises he has all necessary material on hand. Contract was signed and he was instructed to start work at once.

Transportation of School Children at Naval Base.

Mr. John Bean reported 28 children residing on Naval Base desired transportation to Little Flower Sch. He was transporting them, until further arrangements could be made. Mr. Briscoe advised Bd. this was illegal. Mr. Bean instructed to have Chaplain appear before Bd., representing parents of children. Meeting was held at home of Mr. King with Chaplain, Comm Vossler and matter discussed.

Grace Lee, (c01) appeared relative to paying Scanlon Herbert for transportation of 1 child to St. Jos. Sch. She was advised to make no payment at this time.

Scanlon Herbert appeared relative to carrying additional children to St. Jos. col. Sch. Matter under consideration.

Roads.

Messrs. Christman and Chase, residing on Cuckold's Creek-Hollywood Rd. desire information as to procedure for County to assume maintenance of road on which 9 families reside-1000ft. of road in bad condition. They were advised as to procedure.

Mr. Bernard Bowles, 3rd Dist. requested road repairs on road leading from John Somerville's store at rear, to Pincushion and Mr. John Guy's. Road in bad condition, ditches need cleaning. Necessary repairs cannot be made on road before winter weather sets in. Mr. Thompson instructed to clean ditches and gravel road now.

Briscoe Barnes, col., residing in shack on property of Mr. Frank Eliff, in Poplar Hill section, requests permission to move shack to old abandoned road, also on Mr. Eliff's property. Bd. advised him to contact Mr. Eliff in this matter- they have

no objection if Mr. Eliff permits.

Mr. and Mrs. Lloyd Curtiss , Plains, request repairs to road; also used by school bus. Mr. Thompson instructed to clean ditches and blade road now.

All matters requiring Boards' attention must be presented in writing. Bd. meeting room occasionally so crowded with various groups impossible understand persons who are talking. Board requests that all matters for their attention must hereafter be presented in writing, by an authorized representative.
