Mr. Fritz had written Dr. Waters relative to present Health Office Dept. stating it was on A list, for participation in Hill-Burton Bill, Pub. Law 725-79th Cong. for St. of Md., Annual appropriation of \$870,000.00 for 5 yrs for Md. he explained that in the event any county in the State desired to consider a hospital or health center bldg program, the State would appropriate 1/3 of 1/10 of appropriation (wherever it is found there is actual need. Health Dept. would like larger quarters espacially for clinics and suggest that the Bd. get in touch with the Hodpital Bd. and Supt. to ascertain if there is any available space for such clinics. State would pay any expenses incurred in the event walls were cut, or partitions moved etc. Mengthy discussion followed as to St. Mary's ability to care for sick. Dr. Waters urged that room be secured at the hospital, and his office staff remain where it is. Clinics- 18- monthly are crowded. Doctors dislike coming to Health Center due to lack of room.

Messrs. Reeves and Drury could make no promise in matter as they not authorized to do so. Letter was written to Bd. and Supt. requesting they advise the Co. Com. if there is room available. Matter to be discussed on receipt of reply.
