What is needed is to arouseinterest of the people in the matter; let citizens assist in raising funds for Health Officer's salary and to provide for proper health quarters.

Suggested Dr. Harris of Charles Co., who was part time Health officer here immediately after Dr. Ward- Dr. Harris will soon return from a special course in Health Service and will be available for part time duty in St. Mary's, if he has additional compensation Suggests Bd. plan to pay adequate compensation to specially trained health officer to make it worth his while to remain in St. Mary's as other Counties pay part of officer's salary. (\$7 - \$8000.00)

Dr. Riley advised Committee was not here to go too much into defail at this time, but close attention must be paid to areas from which oysters are taken, as unless sanitary conditions improve areas will be closed and thus the State will lose a large sum of money.
