Zoning- Gasparovic- further consideration given to matter. supplementary decision by Mr. Briscoe presented to Bd. advises they sustain their original decision to rezone property "C" commercial which was arrived at from a study of evidence presented at last hearing Fan 26- which tends to show a steady trend of business along the highway from Great Mills Road to 3 Notch and NATC. In 1945 several property owners had their property zoned from "A" to "C" due to the already creeping in of business. A denial, of Mr. Gasparovic's request would hamper development along commercial lines. In the erection of the Bowling Alleys the County also gains an additional sum from taxes

State Roads Commission presented a list of roads and work completed in 1949.

Library Aid.

After several meetings at the home of A.F.King between officers of the St. Mary's County Memorial Lib. Asso. Inc., and JHTBriscoe, King and the commissioners, the Board agreed to lend its support for ONE YEAR ONLY to the library. Letter from R.E. Wigginton, sec. of the above Asso., was the first written proposal or pledge of what Mrs. Davidson proposed to do in regards to a public county library. (letter in files) Mrs. Davidson will lease any part of Tudor Hall (which she has deeded to the S.M.C.M.L Inc.,) necessary for the proper conduct of a library; she any part of Tudor Hall (which she has deeded to the S.M.C.M.L.A. Inc.,) necessary for the proper conduct of a library; she further agrees to operate the library for a period of at least one year at her own expenses, if the County Commissioners will appropriate the 2¢ minimum amt. on the taxable basis; after this is done the State aid for libraries at 80 per capita can be received for purchase of books; Mrs. Davidson will then pay the rest of all expenses, including heat, light, janitor etc. The Commissioners agreed to appropriate a sum equal to the 2¢ tax from the Surplus Fund, for ONE YEAR ONLY in order to determine whether or not the citizens desire such a library.

Lst Nat Bank requested Bd. to close out Sinking Fund and maintain only the CGF #1, from which the necessary amounts will be withdrawn when due for the Sinking Fund.
