Regular Meeting.

The Board of County Commissioners, with all members and their attorney present, met in regular meeting today.

Mr. Roland B. Duke requested the Commissioners sign for a radio used on the Leonardtown Vol. Fire Dept siren, in order that the sales tax may be avoided. Since the volunteer fire apparatus goes to any part of the County this was a legitimate request and Mr. Alvey agreed to sign same.

Mr. Duke also desired to know whether or not the Board desired a Right of Way from the State Highway #5 through a lot he owns to the new Leonardtown Public school site. He was asked to come in on Sept. 11.

Mr. Wm. Aleck Loker requested the Commissioners have signed erected "2 hour parking only" at Lexington Park. At Tulagi and Coral people use the streets for all day parking. Navy will not allow cars parked inside the gates unless they carry insurance for everyone who rides in the cars. Navy has sufficient land for all parking of their employees and all day parking of these employees should not be allowed.

Zoning Ordinance "Certificate of Use and Occupancy" should be taken up by the Planning Board and amended regulations be considered at a Public Hearing to be held on same.

Mr. Niel MacDonald of Silver Spring, Md., signed his contract for work on the Tall Timbers Erosion Relief Project. ERP-1- 120 wokring days. Acts of 1939 require that Bonds be advertised First National Bank is interested in them. Mr. Sterling suggested the Bonds be prepared as well as the advertising by a firm which handles these matters. It may cost \$250.00 but this would follow the proper procedure. Hartford Accident & Indemnity Co will go the Bond for Mr. MacDonald, but desire to know how the County will pay. Bonds are free from taxation of any kind.

Zoning at Patuxent Beach-Mr. Nicolet has copy of plans which should be looked up. Proper zoning will cost between 250-300 He was requested to attend the Pat. Beach Civic Asso meeting and advise that this cost must be borne by the property owners according to the Enabling Act the County can receive gifts, and this could be a gift from the property owners. Chap. 685-Acts of 47 County Commissioners can make special assessments in certain areas to carry out Zoning. This would require a lot of red tape and it was suggested that Mr. Nicolet tell the organization that the costs would have to borne by them (the property owners) due to the condition of the Budget this year. It will cost about \$2.00 each lot. The Patuxent Beach meeting is Sept 3 when the matter of raising the money can be discussed by them.

Judge Loker, attorney for P.E.Gray of Lexington Park, reported on the progress of the theatre parking space.

Messrs. Raum and Williams have purchased the old Fred Norris place in Dean and Capps sub-division. Road was put in when place was sub-divided and was maintained by Capps and Dean until the entire place was was sold some time ago. They were advised the R of W must be 30 ft wide, and present R of W is 15 ft. Dean & Capps have laid off 30 ft of their land and will give same, but Mrs. Raley wants some compensation for her land which Mr. Raum feels, the other property owners will be willing to pay her. Mr. Alvery and Mr. Thompson will view the land in question and report at next meeting.
