SPECIAL MEETING December 4, 1951 2 p.m.

Members of the Board with their attorney and Mr. M.C. Thompson, Jr., attended the meeting with members of the Highway Research Board, Mr. Hebden and Mr. Haas.

The main topic discussed was how this Board felt about there being one highway system, State. It was pointed out that where the Commissioners and the Roads Engineer cooperated it worked out very well with the County having a Roads system, but where there was little or no cooperation it didnt work out so well. The Commissioners explained that they had never considered the matter of changing the system. This was the first Board to be interviewed who could not succeed themselves, and this being their first year in office the matter had never come up.

Another topic discussed was that of the Secondary Road Federal Aid program. Mr. Thompson said he felt that it cost more to receive the Fed. aid than the County could build a road for. Mr. Hebden said that roads would be checked for cars per houraten car hour would not need as heavy a road as a 100 car hour road. He further said that the Commissioners of Frederick County understood just how this worked and had received a great deal of Fed. aid for their secondary roads. He suggested that these Commissioners might do well to contact Frederick County commissioners and see how they worked the matter. The Board said they would consider the matter. Mr. Hebden said that evidently communications from the State office did not make the use of Fed aid clear and that a road such as St. Abdrews Ch. road would be eligible for this aid.

The matter of turning back the roads to be incorporated in one system is one of the subjects to be discussed when the County Commissioners Association meets in Annapolis on Dec 12. All members and their attorney will attend this meeting,
