Roads Mrs. Robt. Mcgee, Mrs. Ed Macon and Mrs Gen Macon met with the Board concerning their road which had already been discussed with Dr. Macon and he was advised Board would include the road in the County road system as soon as possible. Letter was written to Dr. Macon advising him of this, and stating Commissioners hoped to have it done in early spring of 1953.

Board agreed not to pay over \$5 for large turkeys killed by dogs

Mr. Otis Wood, representing Lexington Lions asked for permission to visit Alms House and see about installing radio or somefform of entertainment for inmates. Letter was addressed to Mr. Ford, Supt., asking him to cooperate with Mr. Wood in place to install radio etc.

Roads Mrs. Miller of the 7th again asked for some help in her pad situation. Mr. Jim VanWard is not cooperative. She was advised her only help lay in bringing him before the Trial Magistrate's Court since he had admitted giving her Right of Way thru his farm, which he now keeps filled with refuse etc. Board then said land could be condemned and jury would put a price on it and if R of W is given the County, road will be maintained by County.

St. Mary's Beach- Hines Engr. Corp. Mr. Hines Jr called about a road at St. Mary's Beach Sec 1 was developed in 1947 has 35 permanent homes. Mr. Thompson has seen the roads in this subdivision. Commissioners agreed to take over maintenance of Sec 1 and await further developments in Sec 2 of this tract. To advise Mr. Hines of their decision. Roads in this section are 50 ft streets 20-28 ft.

Zantznger and Waring- lengthy discussion was had about the setback-(Mar 14 and Aug 14,) Mr. Ghent is to prepare drawings showing what they want, with setback line withdrawn, angular parking and setback on opposite side of road. Board would be willing to remove setback line if by doing so will not interfere with traffic.

Waring's Sub-div Road requires 6 inch compacted gravel and pipe 15 in in diameter, road to be shaped up.

Air Raid Sirens have been installed at exington Park and McKay's Beach Vol. Fire Depts and 7th District 2357.05 Check for same made to F.L.Anderson Co of Balto.

Mr. Johnson, on road between Carrol's and Briscoe's near gravel pit has built home, asks that road be graded as far as gravel pit—he built the road as far as the gravel pit himself. Board agreed road to be dragged when dragging Carpll's road to Dietrich's.

Petition for road from St. Andrews' to Wise Corner, to be hard topped.
