The County Commissioners and their attorney met this morning.

Request from Mrs. Gilbert Dorsey for reimbursement for bringing son to meet Paro. Sch bus denied. Trip too long for bus to make for one child, 12 mi round trip per day

Applications denied for claim of damage by dogs from Dr. Walter Graham, begun by him and completed by another person Letter advised him to properly prepare claim and send in for reviewing.

Arthur Briscoe, claim begun by him, completed by his wife, and he appointed as one of the appraisers. Letter advising him how to properly prepare claim was sent.

Mrs. Dorothy Holmes, claim signed by 2 persons, one her daughter, returned with instructions for properly filling out another claim.

Alvin Pomerantz, % Style Center, "exington Park, Md., requested refund on Traders' License which he purchased for store in Mech. Store was sold and he was obliged to sell out his business. No refund allowed.

Mr. O'Brien of Remington, Rand Co called about a safe for the Treasurer's office as he says any safe over 25 years old is not even heat proof and there is grave danger to County records stored in such a safe. He was asked to inspect the old safe and make a report what is needed. Matter will be considered later.

It was decided to have each bus driver physically examined for fitness to drive parochial school bus. This is required by State Bd. of Education., for public school bus drivers. Board agreed it was a good thing and forms were sent out to all bus drivers for the examination which is to be made prior to January 1, 1953. Dr. Houser said have chest xrays made by the Health Dept and this will save the bus driver \$10.00

Mr. Waring and Malcolm Guy, representing citizens residing on Horse Head Road, appeared to request the Commissioners take over the road in that sub-division. Mr. Thompson says the road must have a 6 inch conpacted gravel bed, and 15 inch entrance pipes installed before it meets requirements of SRC. Mr. Waring said at time of building road 4 inch gravel bed was required by SRC. Board agreed to accept road when properly repaired and DEEDed to County, at owners' expense.

Mr. Bailey reported a sharp turnat Staunton Guy's where parochial school bus passes, and asked that it be cut; also road a Geo. Boyd's in bad condition- both dangerous to school busses.

Willows-Jarboesville Road; - letter from Mr. Pierre Ghent about reimbursing him for work on plats etc. Mr. Sterling to dictate letter about this.

Public Hearing at 2;30 on proposed Ordinance and Regulations of Health Dept. Attached hereto. Approved by Commissioners.

Mr. Aubrey Stone asked if there was a public dumping ground, or place for disposal of garbage in County. He suggested County provide these in different sections. Matter not given full conxideration as yet.

Budget reviewed and deductions made. Corrected budget will be ready for Dec 9th meeting.

Clerk instructed to write Treasurer of Charles County for Tax bill in order that this Board may consider printing on each bill the proportion of money used for various items such as Pub sch. Fire and police protection; Roads etc.,
