

June 23, 1953

The full Board of County Commissioners and their attorney met today.

Contractors for parochial school transportation were present and all but 2 signed their contracts as of last year- at existing amounts, with the provision that additional mileage would yield additional fees. Will advertise for contract for J.F. Jean and G. Alex Hebb routes.

Sand Gates Road- Judge Loker, representing a group of taxpayers who reside in this area asked that the old road be abandoned and a new road to the rear of the property be made- the property owners are 3 Plugge brothers, Norman, Gordon and Cameron, 4 Dixon brothers, Edgar, Raymond, William and Harry- it appears that so many people gather on the beach the owners cannot have any privacy, and have lost their riparian rights. Mr. Sterling pointed out that the law requires a Public Notice be inserted in the county papers for 2 weeks advising that the old road will be abandoned and a new one built. A lengthy discussion followed. Part of a road has already been built by the County. The property owners are willing to give as much as 50ft of property if necessary for the new road if located to the rear as they request.

Fr. White Memorial-Snow Hill Road
Property owners along this road ask that road be widened. Mrs. M. Gasparovic is unwilling to give R of W. Mr. Thompson will contact her later and report to the office.
