

December 8, 1953

All members and their attorney were present today when the Board met in regular session.

At 11 a.m. Mr. Alfred Toombs of Bushwood representing the PTA of the 7th, appeared asking that children attending the Pub. School and residing in a certain area in the 7th be permitted to ride on the Par sch busses, as it would prevent them from being on the road so long every day. Mr. Toombs said he, and the PTA felt it would be advantageous to the County to have a single bus system, in which the County Commissioners heartily concur. The Commissioners said they had no objection to the children riding on the Paro busses, provided it didnt overcrowd the busses. The Bd of Educa-
tion was represented by Miss Dent, Mr. J. Claude Johnson, Mrs Maude Gardiner, Mr. Ed Thomas, Abe Weiner, ~~R. Barnes~~ and their attorney ~~Arthur Rysticken~~. ^{Robinson}
^{Barnes} A lengthy discussion was held, and Miss Dent informed that she would not permit any child to board the Paro sch busses without a written request for it to do so, from their parent.

Leonardtwn Pub School

It appears that change in the installation of the sewage system raised the cost and the Town Commissioners requested the Bd of Education to pay \$1600 for this work-the Bd of Education in turn asked the County Commissioners to pay \$800 of the sum. The County Cpm-
missioners were under the impression that the original contract for construction of the school covered the water costs to the main pipe, Miss Dent will confer with the architect and see if this is so then advise the Commissioners.

USNATC-anxious to make a gift to the Alms House asked that the Commissioners decide what should be sent- Commissioners decided a television and mattresses were needed. Letter addressed to Capt McClure advising this; also letter addressed to G.I. Ford, Supt of Alms House advising that whatever the Navy sent was for the use of the inmates and was not to be moved to any part of the house; to stay in the general living room.

Mattingley Sons asked if County would pay the bill for ambulance service to the hospital with 3 men who were shot when apprehended breaking into a warehouse of Burch Bros. It was also necessary to make a box and bury and arm that was amputated from one of the suspected robbers- the Commissioners agreed to do this for \$20.00

Afternoon session Budget for 1954-55 read Present, Dr. A.D.Houser, Health Dept; Miss Eloise Pickrell, Library, Miss Dent, Bd. of Education; Mr and Mrs Cuniberti and son, Mr. Kay of the Beacon. Health Dept budget inceased to pay for one nurse, also increases in salaries of 2 sanitarians and one jr. stenographer. No increase in personnel ; all requested granted.

Library requested additional \$5000, in view of the fact that Bd pays asst librarian's salary, they felt that 4¢ on the \$100 on the basis was all they could grant.

Miss Dent. Requestd 2 teachers to teach driving to pupils of Pub Schools.

Tax Rate set at \$1.50 per \$100.
