All Board members and their attorney met today in regular session.

Tall Timbers.

Wm. Aleck Loker, attorney, representing Mr. Ercole Leonardo owner of waterfront lots 43 & 44, Tall Timbers, asked that the latter be relieved from special taxes for the erosion relief project etc., in this area. Mr. eonardo protested the project from the beginning, altho more than 75% of the taxpayers requested relief, and he has since stated that he would have no part in the matter, as he had previously erected a seawall that is in good condition. A lengthy discussion resulted in settting Friday June 18 at 8:30 pm for a special meeting with Mr. Leonardo and Mr. Loker.

Miller R of W
Mrs Miller of the 7th Dist came in about the R of W thru Mr.
VanWard's farm. This is a matter of long standing- the Board
decided to make Mr. VanWard an offer of \$200 per acre for land
that would be used for the road, this to be done by registered
mail to be sure Mr. VanWard receives it. If this is not acceptable, then condemnation proceedings will be started.

Mr. Chappelear, Breton Beach Road asked that something be done about the road to his property. Since the road would have to thru a marsh he was advised nothing could be done at this time.

Mrs. T. C. Diamond, Dameron, Md., offers a marsh site for use as Public Dump- there is a very good road to the dump, about 1 mile off the state road. She would also like to have the SRC use it for a dump.

Mrs. Cuniberti and others sent in a petition requesting that the roads be cleaned of the trash etc., making them unsightly. Mrs Cuniberti was advised by letter that the Board is doing all possible to clean up this matter.
