High School for Great Mills section, for some of this they hope to

and Miss Dent informed that she feels if the colored schools are in
keeping with those for white pupils there will be no trouble here.

Essex Drive-Midway-ShangriLa
Planning and Zoning Commission strongly urge the improvement of
Essex Drive to be used in connection with the new school in Lexington Park. Midway Dr. to be of use to the school would need lots
of cutting and grading. Later the Commissioners will complete
ShangriLa and Midway drives. MCThompson, Jr., will secure R of W
for these roads.
